Salaries (Comptroller and Auditor General and Others) Order (Northern Ireland) 1987

Made 10th February 1987

Coming into operation 25th March 1987

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

In exercise of the powers conferred by Article 4(2) of the Salaries (Comptroller and Auditor General and Others) (Northern Ireland) Order 1973(a) and now vested in me(b) and of all other powers enabling me in that behalf, I hereby make the following Order:

Title and commencement

1. This Order may be cited as the Salaries (Comptroller and Auditor General and Others) Order (Northern Ireland) 1987 and shall come into operation on 25th March 1987.

Revocation

2. The Salaries (Comptroller and Auditor General and Others) Order (Northern Ireland) 1985(c) is hereby revoked.

Increases in salaries

3.—(1) The annual salary payable to the Comptroller and Auditor General shall be increased as follows—

- (a) from £35,038 to £38,325 from 1st July 1985;
- (b) from £38,325 to £40,000 from 1st March 1986;
- (c) from £40,000 to £43,500 from 1st July 1986.

(2) The annual salary payable to the Parliamentary Commissioner and the Commissioner for Complaints shall be increased from 1st July 1986 from £37,000 to £38,425.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order provides for increases in the annual salaries payable to the Comptroller and Auditor General for Northern Ireland, the Northern Ireland Parliamentary Commissioner for Administration and the Northern Ireland Commissioner for Complaints.

Article 3(1) increases the annual salary payable to the Comptroller and Auditor General from £35,038 to £38,325 with effect from 1st July 1985, from £38,325 to £40,000 with effect from 1st March 1986 and from £40,000 to £43,500 with effect from 1st July 1986. These increases are backdated to facilitate the upgrading of this position and to take account of the recommendations made in the Reports of the Review Body on Top Salaries in 1985 and 1986 (HMSO, Cmnd 9525 and 9785).

Article 2 revokes the Salaries (Comptroller and Auditor General and Others) Order (Northern Ireland) 1985 under which the salary payable to the Comptroller and Auditor General was £35,038 with effect from 1st July 1985 and £37,000 with effect from 1st March 1986.

This Order is made with retrospective effect by virtue of Article 4(2) of the Salaries (Comptroller and Auditor General and Others) (Northern Ireland) Order 1973.
