**The Social Security (1986 Order) (Commencement No. 8) Order
(Northern Ireland) 1988***Made**31st March 1988*

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(3) of the Social Security (Northern Ireland) Order 1986(a), paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following order:

Citation and interpretation

1.—(1) This order may be cited as the Social Security (1986 Order) (Commencement No. 8) Order (Northern Ireland) 1988.

(2) In this order, references to Articles and Schedules are references to Articles of, and Schedules to, the Social Security (Northern Ireland) Order 1986.

Appointed day

2. The day appointed for the coming into operation of the provisions of the Social Security (Northern Ireland) Order 1986 which are specified in the Schedule to this order is 11th April 1988.

Revocations

3. In the Social Security (1986 Order) (Commencement No. 6) Order (Northern Ireland) 1987(c), the provisions in the Schedule to that order which relate to the coming into operation of the following provisions of the Social Security (Northern Ireland) Order 1986 are hereby revoked, that is to say—

- (a) Schedule 3, paragraph 1 so far as it relates to paragraph 11, paragraph 11, and Article 40 so far as it relates to those paragraphs; and
- (b) the repeals in Schedule 10, and Article 83(2) so far as it relates to those repeals, of the following provisions—
 - (i) in the Social Security (Northern Ireland) Act 1975(d) in Schedule 4, in Part V, paragraphs 13 and 15, and in Schedule 17, the definitions of “The deceased” and “Industrial death benefit”,

- (iv) in the Pneumoconiosis, etc., (Workers' Compensation) (Northern Ireland) Order 1979(c), in Article 2(2), the definition of "death benefit".

EXPLANATORY NOTE

(This note is not part of the Order.)

Article 2 of this order brings into operation on 11th April 1988 the provisions of paragraphs 8 and 10 of Schedule 3 to the Social Security (Northern Ireland) Order 1986 (which relate to industrial death benefit) and consequential repeals.

Article 3 revokes provisions in the Schedule to the Social Security (1986 Order) (Commencement No. 6) Order (Northern Ireland) 1987 (S.R. 1987 No. 299 (C. 11)) relating to the coming into operation on 11th April 1988, of paragraph 11 of Schedule 3 to the Social Security (Northern Ireland) Order 1986 (widower's death benefit) and of specified repeals in Schedule 10 to that Order which relate or refer to industrial death benefit.
