**The Licensing (1987 Order) (Commencement No. 2) Order  
(Northern Ireland) 1988**

*Made* . . . . . *11th January 1988*

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 1(2) of the Licensing (Northern Ireland) Order 1987(a), paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(b) and of all other powers enabling it in that behalf, hereby makes the following order:

*Citation*

1. This order may be cited as the Licensing (1987 Order) (Commencement No. 2) Order (Northern Ireland) 1988.

*Appointed day*

2. The day appointed for the coming into operation of the provisions of Article 3 of the Licensing (Northern Ireland) Order 1987 (prohibition of consumption of intoxicating liquor at entertainments organised for gain) is 1st February 1988.

## EXPLANATORY NOTE

*(This note is not part of the Order.)*

Article 2 of this order brings into operation on 1st February 1988 the provisions of Article 3 of the Licensing (Northern Ireland) Order 1987, which amend the Licensing Act (Northern Ireland) 1971.

Sections 1A and 52A of that Act, as inserted by Article 3 of that Order, provide for the prohibition of the supply, keeping for consumption or consumption of intoxicating liquor at certain entertainments organised for gain and the penalty for the contravention of any of those prohibitions.
