Further Education Teachers' Salaries (Amendment No. 2) Regulations (Northern Ireland) 1988

The Department of Education, in exercise of the powers conferred on it by Articles 69(1) and (4), 70(1)(b) and 134(1) of the Education and Libraries (Northern Ireland) Order 1986(a), and by section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and of every other power enabling it in that behalf, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Further Education Teachers' Salaries (Amendment No. 2) Regulations (Northern Ireland) 1988 and shall come into operation on 31st July 1988 and except where otherwise provided shall have effect on and from 1st July 1988.

Amendment to the Further Education Teachers' Salaries Regulations (Northern Ireland) 1988

- 2. The Further Education Teachers' Salaries Regulations (Northern Ireland) 1988(c) shall be amended as follows—
 - (a) in regulation 10 (head of department) for the sums "£1,728" and "£1,533" there shall be substituted "£1,833" and "£1,626" respectively;
 - (b) in regulation 14(2) (safeguarding of salaries) with effect on and from 1st September 1988 there shall be substituted for the words "if the board by whom he is employed consents" the words "if the Department approves";
 - (c) in regulation 18(1) (payment of unqualified teachers) for "£5,163" there shall be substituted "£5,472";
 - (d) in regulation 19(2) (payment of part-time teachers) for the sums "£15.96", "£13.60" and "£10.00", there shall be substituted "£16.92", "£14.42" and "£10.60" respectively;
 - (e) for regulation 24 (payment for additional teaching duties) there shall be substituted with effect on and from 1st September 1988—
 - "24.—(1) This regulation shall apply only to teachers who are lecturers, senior lecturers or principal lecturers.

- (2) For the purposes of this regulation weekly teaching hours and duties shall be related to the week commencing on Monday and ending on Sunday both days inclusive.
- (3) Payments shall be made to teachers for any additional weekly teaching duties undertaken by them and shall be calculated in accordance with the hourly rates for part-time teachers as set out in regulation 19(2) and the assessment of the period of such additional teaching duties and the calculation of the amount of payment in respect thereof shall be made in accordance with arrangements approved by the Department.";
- (f) in regulation 25 (teachers in service on 31st August 1987) for "31st August 1987" there shall be substituted "30th June 1988";
- (g) in Schedule 1 (salary scales and salary ranges)—
 - (i) for paragraphs 1, 10 and 11 there shall be substituted respectively the paragraphs 1, 10 and 11 of the Schedule;
 - (ii) in paragraphs 3 and 8 for "£14,001" there shall be substituted "£14,841";
 - (iii) for paragraph 4 there shall be substituted—
 - "4. A lecturer who was entitled to an additional £501 per annum under paragraph 4 or 5 of Schedule 1 to the Further Education Teachers' Salaries Regulations (Northern Ireland) 1988 as they had effect on 30th June 1988 shall instead be entitled to an additional £531 per annum.";
 - (iv) for paragraph 5 there shall be substituted—
 - "5. Subject to paragraph 7 a lecturer, other than a lecturer to whom paragraph 4 applies, who at 31st August 1987 was being paid on point 11 of the lecturer grade II scale, shall have the date on which his next complete year of service would be attained calculated and if the following day falls on any of the first fifteen days of the month the lecturer shall be entitled to an additional £531 per annum on and from the first day of that month but otherwise on and from the first day of the following month subject to satisfactory continuous full-time service in the meantime.";
 - (v) in paragraph 6 for "£501 per day annum" there shall be substituted "£531 per annum";
 - (vi) after paragraph 9 (principal lecturer) there shall be inserted the following paragraph—
- "9A.—(1) A principal lecturer who at 31st August 1988 is being paid on point 8 of the principal lecturer scale shall be entitled to proceed to point 9—
 - (a) on and from 1st September 1988, provided that at 31st August 1988 he had satisfactorily completed at least 11 months and 15 days service on point 8 of the principal lecturer scale;
 - (b) on and from 1st October 1988, where at 31st August 1988 service on point 8 of the principal lecturer scale amounting to 11 months and a lesser number of days than fifteen had been satisfactorily completed.

- (2) Where at 31st August 1988 service on point 8 of the principal lecturer scale amounted to 11 months or less the date on which the next complete year of service would be attained shall be calculated and if the following day falls on any of the first fifteen days of the month the principal lecturer shall be entitled to proceed to point 9 on and from the first day of that month but otherwise on and from the first day of the following month subject to satisfactory continuous full-time service in the meantime.
- (3) Where a principal lecturer is paid on point 8 of the principal lecturer scale with effect on and from a date after 31st August 1988, the date on which his next complete year of service would be attained shall be calculated and if the following day falls on any of the first fifteen days of a month, he shall be entitled to proceed to point 9 on and from the first day of that month but otherwise on and from the first day of the following month subject to satisfactory continuous full-time service in the meantime.";
- (h) for Part I of Schedule 2 (transfer to salary scales applicable from 1st September 1987) there shall be substituted the following—

PART I

Transfer to Salary Scales Applicable from 1st July 1988

A teacher who on 1st July 1988 was, and had immediately before that date been, in teaching service in an institution of further education shall, from that date, enter the scale or salary range as appropriate in Schedule 1 corresponding to his scale or salary range in force immediately before that date at the corresponding incremental point on the scale or position within the salary range.";

- (i) in Part II of Schedule 2 (salary placing of teachers appointed on or after 31st March 1988)—
 - (i) for "31st March 1988" in all places where it occurs there shall be substituted "1st July 1988";
 - (ii) in paragraph 2(b) for the words "paragraphs 8 to 11" there shall be substituted the words "paragraphs 4 to 11";
- (j) Schedule 3 (calculation of payment to teachers for additional teaching duties) is revoked with effect on and from 1st September 1988.

Education EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Further Education Teachers' Salaries Regulations (Northern Ireland) 1988 ("the principal regulations") and give effect from 1st July 1988 to an increase of 6% in salaries and allowances for teachers in institutions of further education.

Revised salary scales and salary ranges are set out in the Schedule.

The revised maximum allowances for certain heads of department are set out in regulation 2(a).

Regulation 2(b) provides with effect from 1st September 1988 that the safeguarding of salaries as a result of an event other than closure or reorganisation of a grant-aided school or an institution of further education is to be subject to the approval of the Department of Education rather than an education and library board.

The revised rate of salary for unqualified teachers is set out in regulation 2(c).

Revised hourly rates of pay for part-time teachers are set out in regulation 2(d).

Provision has been made in regulation 2(e), with effect from 1st September 1988, for payment for additional teaching duties to be in accordance with arrangements approved by the Department of Education.

The provision for the protection of the salaries of full-time teachers in post has been updated in regulation 2(f).

The additional amount which certain lecturers receive has been increased (regulation 2(g)).

Regulation 2(g) also provides for the payment of a further point on the principal lecturer scale.

Regulation 2(i) provides that a lecturer who on or after 1st July 1988 is reappointed for the first time in the same capacity as that in which he had been employed at any time before that date shall be placed on the lecturer scale at the incremental point corresponding to the point on which he was paid at the date of leaving his previous employment or if reappointed after a break in service, at the rate of salary determined under paragraphs 4 to 7 of Part II of Schedule 2 to the principal regulations if this is higher than the corresponding incremental point.

These regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
