STATUTORY RULES

The Statutory Rules (Exemption) Regulations (Northern Ireland) 1988

Made 7th September 1988 Coming into operation . 28th September 1988

Whereas the Department of Finance and Personnel(a) is satisfied that adequate arrangements exist for bringing, so far as is reasonably practicable, notice of the making of orders by the Department of the Environment(b) extinguishing, for the purposes of improving the amenity of any area, of the right which persons may have to use vehicles on a road, being a road other than a trunk or special road, to persons appearing to be affected by them and for supplying (whether upon payment or otherwise) of copies of them to persons applying for such copies.

Now, therefore, the Department of Finance and Personnel in exercise of the powers conferred on it by Articles 5(2)(c) and 7(1) and (2) of the Statutory Rules (Northern Ireland) Order 1979(c) and paragraph 2(1) of Schedule 1 to the Northern Ireland Act 1974(d) and of every other power enabling it in that behalf, with the concurrence of the Lord Chief Justice, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Statutory Rules (Exemption) Regulations (Northern Ireland) 1988 and shall come into operation on 28th September 1988.

Exemptions from requirements as to printing and sale

2. Orders made by the Department of the Environment under Article 77(1) of the Planning (Northern Ireland) Order 1972(e) are hereby exempted from the requirements of Article 5(2)(c) of the Statutory Rules (Northern Ireland) Order 1979.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

For the purpose of improving the amenity of any area Article 77(1) of the Planning (Northern Ireland) Order 1972 provides that the Department of the Environment may make orders extinguishing rights which persons may have to use vehicles on any road, other than a trunk road or a special road. These regulations exempt such orders from the requirements of Article 5(2)(c) of the Statutory Rules (Northern Ireland) Order 1979 which requires arrangements to be made for the printing and sale of statutory rules.
