**The Farm Diversification Grant (Amendment No. 2) Scheme
(Northern Ireland) 1988**

Made 23rd November 1988

Coming into operation 2nd January 1989

The Department of Agriculture, in exercise of the powers conferred on it by Article 16(1) of the Agriculture and Fisheries (Financial Assistance) (Northern Ireland) Order 1987(a) and every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel, hereby makes the following Scheme:—

Citation and commencement

1. This Scheme may be cited as the Farm Diversification Grant (Amendment No. 2) Scheme (Northern Ireland) 1988 and shall come into operation on 2nd January 1989.

Amendment to the Farm Diversification Grant Scheme (Northern Ireland) 1987

2. In Article 5(2) of the Farm Diversification Grant Scheme (Northern Ireland) 1987(b) after sub-paragraph (d) there shall be inserted the following sub-paragraph—

- “(e) proposed expenditure in relation to any work, facility or transaction—
- (i) which is of a kind specified in item 7(a) to (d) in Column 2 of the Schedule in respect of an ancillary farm business of a kind specified in paragraph 5 of Column 1 of the Schedule (provision of facilities for sports and recreation) or in respect of the letting of any land for the purposes of such a business; or
 - (ii) which is of a kind specified in item 6(b) or (c) in Column 2 of the Schedule in respect of an ancillary farm business of a kind specified in paragraph 6 of Column 1 of the Schedule (provision of educational facilities relating to farming and the countryside and to farm-based industry) or in respect of the letting of any land for the purposes of such a business; or

- (iii) which is necessary or incidental to the carrying out of any work, facility or transaction of a kind mentioned in this sub-paragraph for the purposes mentioned in this sub-paragraph.

where that work, facility or transaction is to be carried out on any set-aside land which has been set aside in accordance with the Set-Aside Regulations (Northern Ireland) 1988(a).”.

EXPLANATORY NOTE

(This note is not part of the Scheme.)

This Scheme amends the Farm Diversification Grant Scheme (Northern Ireland) 1987 by providing that the Department will not approve farm diversification plans containing proposals for the carrying out of certain land improvement works on land which has been withdrawn from agricultural production under the Set-Aside Regulations (Northern Ireland) 1988.
