## EDUCATION

**The Teachers' Superannuation (Amendment) Regulations  
(Northern Ireland) 1988***Made* . . . . . 4th March 1988*Coming into operation* . . . . . 3rd April 1988

The Department of Education in exercise of the powers conferred on it by Articles 11(1) and (2) of, and paragraph 13 of Schedule 3 to the Superannuation (Northern Ireland) Order 1972(a) and of every other power enabling it in that behalf, and after consultation with representatives of education and library boards and of teachers and with such representatives of other persons likely to be affected by the regulations as appear to it to be appropriate as required by Article 11(5) of the said Order, with the consent of the Department of Finance and Personnel(b), hereby makes the following regulations:—

*Citation and commencement*

1. These regulations may be cited as the Teachers' Superannuation (Amendment) Regulations (Northern Ireland) 1988 and shall come into operation on 3rd April 1988.

*Interpretation*

2.—(1) In these regulations "the principal regulations" mean the Teachers' Superannuation Regulations (Northern Ireland) 1977(c).

(2) References in these regulations to a numbered regulation or a numbered schedule in the absence of a provision to the contrary are references to the regulation or schedule so numbered in the principal regulations.

*Amendment of the principal regulations*

3.—(1) Regulations 4(b) and (d) of the Teachers' Superannuation (Amendment No. 2) Regulations (Northern Ireland) 1987(d) shall be revoked.

(2) Regulations 79 to 91 shall be renumbered 80 to 92 and paragraphs (c) to (f) of regulation 81 as renumbered by this regulation shall be renumbered (d) to (g).

(3) In regulation 17(1) (Return of Contributions by payment of instalments) for "(3)" and "(4)" there shall be substituted "(2)" and "(3)".

#### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These regulations remedy cross-reference defects in the Teachers' Superannuation Regulations (Northern Ireland) 1977 which resulted from the renumbering of certain provisions therein by the Teachers' Superannuation (Amendment) Regulations (Northern Ireland) 1987 and the Teachers' Superannuation (Amendment No. 2) Regulations (Northern Ireland) 1987.
