The Lord Chancellor, in exercise of the powers conferred by Articles 3(2), 7(3) and 22(1) of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981(a) and now vested in him(b), hereby makes the following Regulations-

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the Legal Advice and Assistance (Financial Conditions) Regulations (Northern Ireland) 1988 and shall come into operation on 11th April 1988.

(2) In these Regulations "the Order" means the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981.

Revocation

2. The Regulations specified in the first column of the Schedule shall be revoked to the extent specified in the third column of that Schedule.

Persons eligible for advice and assistance

3.—(1) For the weekly sum of £118 specified in Article 3(1)(c) of the Order, there shall be substituted the weekly sum of £122.

(2) For the capital sum of \pounds 825 specified in Article 3(1) of the Order, there shall be substituted the sum of £850 except in relation to assistance by way of representation (for which the sum remains $\pm 3,000(c)$).

Contributions from persons receiving advice and assistance

4. For the weekly sum of $\pounds 56$ specified in Article 7(2) of the Order, there shall be substituted the weekly sum of £58.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations increase the financial limits of eligibility for legal advice and assistance under Part II of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981.

The income limits are increased to make legal advice and assistance available to those with disposable incomes of not more than $\pounds 122$ a week (instead of $\pounds 118$) and available without payment of a contribution to those with disposable incomes of $\pounds 58$ a week or less (instead of $\pounds 56$).

The capital limit is increased to make legal advice and assistance available to those with disposable capital of not more than \pounds 850 (instead of \pounds 825).
