**The Export of Sheep (Prohibition) (No. 3)  
Amendment (No. 2) Order (Northern Ireland) 1989**

*Made* . . . . . 26th April 1989

*Coming into operation* . . . . . 27th April 1989

The Department of Agriculture in exercise of the powers conferred on it by Article 32 of the Diseases of Animals (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf, in the interests of human health hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as The Export of Sheep (Prohibition) (No. 3) Amendment (No. 2) Order (Northern Ireland) 1989 and shall come into operation on 27th April 1989.

*Amendment of The Export of Sheep (Prohibition) (No. 3) Order (Northern Ireland) 1987*

2. The Export of Sheep (Prohibition) (No. 3) Order (Northern Ireland) 1987(b) is hereby amended by substituting for Article 2(4)(b) the following sub-paragraph:—

- “(b) any sheep which was marked, as a condition of the granting of a consent under section 2(1) of the Food and Environment Protection Act 1985(c) to its removal from a designated area—
- (i) with an apricot mark, in the case of a consent given on or before 31st July 1988;
  - (ii) with a green mark, in the case of a consent given on or before 2nd October 1988; or
  - (iii) with a blue mark, in the case of a consent given on or before 8th January 1989.”.

*Revocation*

3. The Export of Sheep (Prohibition) (No. 3) Amendment Order (Northern Ireland) 1989(d) is hereby revoked.

### EXPLANATORY NOTE

*(This note is not part of the Order.)*

This Order amends The Export of Sheep (Prohibition) (No. 3) Order (Northern Ireland) 1987 (“the principal Order”) which prohibits, subject to exceptions, the export from Northern Ireland to a Member State of the European Communities of—

- (a) sheep moved from a place in an area designated for the purposes of Part I of the Food and Environment Protection Act 1985 in accordance with the terms of a consent under section 2(1) of that Act which required that the sheep to which it applies should be marked in a specified manner; and
- (b) sheep which have been moved in contravention of a restriction imposed by an order made under section 1 of that Act.

The principal Order does not apply to those sheep which have been examined and subsequently marked with an ear-tag by a person authorised by the Minister of Agriculture, Fisheries and Food, the Secretary of State for Scotland or Wales or the Department of Agriculture or to those sheep moved from a designated area in accordance with the terms of a consent given on or before 31st July 1988, 2nd October 1988 or 10th January 1988 which required them to be marked with an apricot, green or a blue paint mark respectively. This Order extends the exception in the principal Order to any sheep moved from a designated area in accordance with the terms of a consent given on or before 8th January 1989 which required it to be marked with a blue paint mark.

Any person who without lawful authority, or excuse, proof of which shall lie on him, contravenes any provision of this Order shall be guilty of an offence against the Diseases of Animals (Northern Ireland) Order 1981. The penalties for such an offence are, on summary conviction, a fine not exceeding £2,000 or in the case of an offence committed with respect to more than 5 animals, not exceeding £400 per animal.
