The Department of Economic Development, in exercise of the powers conferred on it by section 56(1), (2) and (5) of the Finance Act 1973(a) and of every other power enabling it in that behalf, with the consent of the Department of Finance and Personnel(b), hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the European Economic Interest Grouping (Fees) Regulations (Northern Ireland) 1989 and shall come into operation on 17th July 1989.

Interpretation

2.—(1) The Interpretation Act (Northern Ireland) 1954(c) shall apply to these Regulations as it applies to a Measure of the Northern Ireland Assembly.

(2) In these Regulations—

- "the EC Regulation" means Council Regulation (EEC) No. 2137/85 of 25th July 1985 on the European Economic Interest Grouping (EEIG)(d);
- "EEIG" means a European Economic Interest Grouping formed in pursuance of Article 1 of the EC Regulation;
- "the Order" means the Companies (Northern Ireland) Order 1986(e) (any reference to a numbered Article being to an Article of that Order);
- "the principal Regulations" means the European Economic Interest Grouping Regulations (Northern Ireland) 1989(f); and
- "the relevant Community obligations" means the Community obligations of the United Kingdom under Article 39 of the EC Regulation.

Fees

3. The fees payable in connection with the services and facilities provided by the Department of Economic Development in pursuance of the relevant Community obligations relating to the matters set out in the first column of the Schedule, implemented in part by the principal Regulations, shall be the fees payable to the registrar of companies set out in the second column of the Schedule.

Disposal of fees

4. All fees received under these Regulations shall be paid into the Consolidated Fund.

These Regulations prescribe the fees payable in connection with services and facilities provided by the Department of Economic Development in pursuance of Community obligations of the United Kingdom under Council Regulation (EEC) No. 2137/85 (O.J. No. L199, 31.7.85, p. 1), implemented in part by the European Economic Interest Grouping Regulations (Northern Ireland) 1989. The fees are as follows:—

- 1. for registration of a European Economic Interest Grouping (EEIG) whose official address is in Northern Ireland, the amount of the fee is the same as is payable for registration of a company on its formation (£50.00 under the Companies (Consolidation of Fees) Regulations (Northern Ireland) 1987).
- for each inspection of documents and particulars relating to an EEIG, the amount of the fee is the same as is payable for inspection of documents under Articles 409(4) and 658(1) of the Companies (Northern Ireland) Order 1986 (£1.00 under the Companies (Consolidation of Fees) Regulations (Northern Ireland) 1987).
- 3. for delivering or sending by post by the registrar of companies of a copy or extract of any document or particulars delivered to and kept by him under the European Economic Interest Grouping Regulations (Northern Ireland) 1989, the amount of the fee is £4.00.
