**The Industrial Relations (Recoupment of Unemployment
Benefit and Income Support) (Amendment)
Regulations (Northern Ireland) 1989**

Made 1st December 1989

Coming into operation 1st January 1990

The Department of Health and Social Services and the Department of Economic Development(a), acting jointly in exercise of the powers conferred on them by Article 72(1) and (2) of the Industrial Relations (Northern Ireland) Order 1976(b) and of all other powers enabling them in that behalf, hereby make the following regulations:

Citation, commencement and interpretation

1.—(1) These regulations may be cited as the Industrial Relations (Recoupment of Unemployment Benefit and Income Support) (Amendment) Regulations (Northern Ireland) 1989 and shall come into operation on 1st January 1990.

(2) In these regulations “the principal regulations” means the Industrial Relations (Recoupment of Unemployment Benefit and Income Support) Regulations (Northern Ireland) 1977(c).

Amendment of regulation 2 of the principal regulations

2. In regulation 2(2) of the principal regulations (interpretation) for the definition of “the Secretary of the Tribunals” there shall be substituted the following definition—

“ “the Secretary of the Tribunals” means the person for the time being acting as the Secretary of the Office of Industrial Tribunals and the Fair Employment Tribunal;”.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations further amend the Industrial Relations (Recoupment of Unemployment Benefit and Income Support) Regulations (Northern Ireland) 1977 by substituting a new definition of "the Secretary of the Tribunals".

This amendment is consequential on section 2(1) of the Fair Employment (Northern Ireland) Act 1989 (c. 32) which provides for the establishment of the Fair Employment Tribunal for Northern Ireland. That section is brought into force on 1st January 1990 by virtue of Article 2(1) of the Fair Employment (Northern Ireland) Act 1989 (Commencement) Order 1989 (S.I. 1989/1928 (C. 61)).
