## PLANT HEALTH

Plant Health (Amendment No. 2) Order  
(Northern Ireland) 1989

Made . . . . . 7th December 1989

Coming into operation . . . . . 8th December 1989

The Department of Agriculture in exercise of the powers conferred on it by section 2(a) of the Plant Health Act (Northern Ireland) 1967(b) and of every other power enabling it in that behalf, hereby makes the following Order:

*Citation and commencement*

1. This Order may be cited as the Plant Health (Amendment No. 2) Order (Northern Ireland) 1989 and shall come into operation on 8th December 1989.

*Amendment of Plant Health Order (Northern Ireland) 1988*

2. The Plant Health Order (Northern Ireland) 1988(c) shall be amended as provided in Articles 3 and 4.

3. In Schedule 3 Part VI after Item 84 there shall be inserted the following Item—

<p>“84A. Raw vegetables from plants of: Horseradish (<i>Armoracia</i> L.) Radish (<i>Raphanus</i> L.)</p>	<p>Where the consignment originates in the Netherlands it shall be free from foliage.”</p>

4. In Schedule 3 Part VII B—

(a) in the title for the words “*Castanea, Dendranthema, Dianthus, Gladiolus, Gypsophila, Protea, Prunus, Quercus, Rosa, Salix, Syringa AND Vitis*” there shall be substituted “*Achillea, Anemone, Antirrhinum, Aster, Calendula, Callistephus, Carthamus, Castanea, Chrysanthemum, Centaurea, Cirsium, Dendranthema, Dianthus, Gladiolus, Gypsophila, Liatris, Lisianthus, Protea, Prunus, Quercus, Rosa, Salix, Solidago, Solidaster, Syringa, Vitis AND Zinnia*”;

(b) in column (2) of Item 86 after “*Castanea* Mill.” there shall be inserted—

“*Chrysanthemum* L. (including *Chrysanthemum coccineum* Willd. (syn. *Tanacetum coccineum* (Willd.) Grierson) (Pyrethrum), *Chrysanthemum leucanthemum* L. (syn. *Leucanthemum vulgare* (Lam.)), *Chrysanthemum maximum* Ramond (syn. *Leucanthemum maximum* (Ramond) DC.) and *Chrysanthemum parthenium* L. (syn. *Tanacetum parthenium* (L.) Sch. Bip.) (*Chrysanthemum matricaria*)”); and

(c) after Item 90 there shall be inserted the following Item—

“90A. Cut flowers of the genera:

*Achillea* L.  
*Anemone* L.  
 Mona Lisa type  
 only)  
*Antirrhinum* L.  
*Aster* L.  
*Calendula* L.  
*Callistephus* Cass.  
*Carthamus* L.  
*Centaurea* L.  
*Cirsium* Miller  
*Liatris* Schreiber  
*Lisianthus* P.  
 Browne (syn.  
*Lisianthus* L.)  
*Solidago* L.  
*Solidaster* Wehrh.  
*Zinnia* L.

Where the consignment originates in the Netherlands it shall be accompanied by a phytosanitary certificate.”.

## EXPLANATORY NOTE

(This note is not part of the Order.)

This Order, which comes into operation on 8th December 1989, amends the Plant Health Order (Northern Ireland) 1988 ("the principal order") by—

- (a) requiring that consignments of raw horseradish and radish originating in the Netherlands may only be imported when free of foliage (Article 3);
- (b) adding *Chrysanthemum* L. to the list of cut flowers which may only be imported when accompanied by a phytosanitary certificate (Article 4(b)); and
- (c) requiring that consignments of cut flowers of the genera *Achillea*, *Anemone*, *Antirrhinum*, *Aster*, *Calendula*, *Callistephus*, *Carthamus*, *Centaurea*, *Cirsium*, *Liatris*, *Lisianthus*, *Solidago*, *Solidaster* and *Zinnia* originating in the Netherlands may only be imported when accompanied by a phytosanitary certificate (Article 4(c)).

The principal order will be further amended when the Plant Health (Amendment) Order (Northern Ireland) 1989 (S.R. 1989 No. 426) comes into operation on 15th December 1989.
