Personal Pensions (Appropriate Authority) (Designation) Order (Northern Ireland) 1989

Made 23rd February 1989

Coming into operation 16th March 1989

In exercise of the powers conferred upon me by Article 18(4) of the Social Security (Northern Ireland) Order 1986(a) and of all other powers enabling me in that behalf, I hereby make the following order:

Citation and commencement

1. This order may be cited as the Personal Pensions (Appropriate Authority) (Designation) Order (Northern Ireland) 1989 and shall come into operation on 16th March 1989.

Designation of the appropriate authority

2. For the purposes of Article 18(2) and (4) (General power to modify statutory provisions) of the Social Security (Northern Ireland) Order 1986, the Minister of the Crown or government department, as the case may be, mentioned in column 1 of the Schedule is hereby designated as the appropriate authority in relation to the statutory provisions specified opposite thereto in column 2.

EXPLANATORY NOTE

(This note is not part of the Order.)

Under Article 18(2) of the Social Security (Northern Ireland) Order 1986 (“the Order of 1986”) the Department of Health and Social Services (“the Department”) may by regulations provide that certain statutory provisions shall have effect subject to such modifications as it considers necessary or expedient in consequence of Part II of the Order of 1986 which makes provision for personal pension schemes and amends the law relating to occupational pension schemes.

Before making such regulations modifying any statutory provisions, the Department must consult with the appropriate authority designated in relation to those statutory provisions and obtain its consent to them.

This Order designates the appropriate authority for such purposes in relation to the statutory provisions listed in the Schedule thereto.
