## Legal Advice and Assistance (Financial Conditions) Regulations (Northern Ireland) 1989

The Lord Chancellor, in exercise of the powers conferred by Articles 3(2), 7(3), 22(1) and 27 of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981(a) and now vested in him(b), hereby makes the following Regulations—

#### Citation, commencement and interpretation

**1.**—(1) These Regulations may be cited as the Legal Advice and Assistance (Financial Conditions) Regulations (Northern Ireland) 1989 and shall come into operation on 10th April 1989.

(2) In these Regulations "the Order" means the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981.

### Revocation

2. The Legal Advice and Assistance (Financial Conditions) Regulations (Northern Ireland) 1988(c) are hereby revoked.

#### Persons eligible for advice and assistance

**3.**—(1) For the weekly sum of  $\pounds 122$  specified in Article 3(1) of the Order(d), there shall be substituted the weekly sum of  $\pounds 128$ .

(2) For the capital sum of £850 specified in Article 3(1) of the Order(d), there shall be substituted the capital sum of £890 except in relation to assistance by way of representation (for which the sum remains £3,000(e)).

### Contributions from persons receiving advice and assistance

4. For the weekly sum of £58 specified in Article 7(2) of the Order(d), there shall be substituted the weekly sum of £61.

# Legal Aid and Advice EXPLANATORY NOTE

### (This note is not part of the Regulations.)

These Regulations increase the financial limits of eligibility for legal advice and assistance under Part II of the Legal Aid, Advice and Assistance (Northern Ireland) Order 1981.

The income limits are increased to make legal advice and assistance available to those with disposable incomes of not more than £128 a week (instead of £122) and available without payment of a contribution to those with disposable incomes of £61 a week or less (instead of £58).

The capital limit is increased to make legal advice and assistance available to those with disposable capital of not more than £890 (instead of £850). The capital limit in relation to assistance by way of representation remains at  $\pounds 3,000$ .
