# Parking Places on Roads (Amendment) Order (Northern Ireland) 1989

WHEREAS it appears to the Department to be necessary to provide suitable parking places for vehicles.

NOW THEREFORE the Department in exercise of the powers conferred on it by Article 104(1)(c) of the Road Traffic (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf makes the following Order:—

#### Citation and commencement

1. This Order may be cited as the Parking Places on Roads (Amendment) Order (Northern Ireland) 1989 and shall come into operation on 30th April 1989.

#### Amendment

- 2. The Parking Places on Roads Order (Northern Ireland) 1988(b) shall be amended by:—
  - 1. the addition to the Schedule of the items in Schedule 1;
  - 2. the deletion from the Schedule of the items in Schedule 2.

#### SCHEDULE 1

- 76. Moyle Hill, Ballywalter, (West Side) from a point approximately 46 metres from its junction with Greyabbey Road, for a distance of approximately 3 metres.
- 77. Great Northern Street, Belfast, (West Side) from a point approximately 24 metres north of its junction with Windsor Drive, for a distance of approximately 5.5 metres.
- 78. Parking Area, Ravenhill Court, Belfast, (North Side) from a point approximately 20 metres north of its junction with Ravenhill Court, for a distance of approximately 2 metres.
- Henderson Avenue, Conlig, (South Side) from a point approximately 106
  metres from its junction with Tower Road, for a distance of approximately 6
  metres.
- 80. Bridge Street, Downpatrick, (West Side) from a point approximately 36 metres from its junction with Church Avenue, for a distance of approximately 3 metres.
- 81. Kinnegar Court, Holywood, (East Side) from a point approximately 51 metres from its junction with Kinnegar Drive, for a distance of approximately 5 metres.
- 82. Kinnegar Court, Holywood, (West Side) from a point approximately 56 metres from its junction with Kinnegar Drive, for a distance of approximately 5 metres.
- 83. Avonmore Park, Lisburn, parking area to the rear of No. 123 (South-East Side) from a point approximately 67 metres south of its access road for a distance of approximately 5 metres.
- 84. East Street, Newtownards, (South Side) from a point approximately 20 metres from its junction with Windmill Row, for a distance of approximately 6 metres.

- No. 5. Clarawood Park, Belfast.
- No. 19. St. Jude's Parade, Belfast.
- No. 21. Strandburn Street, Belfast.

# **EXPLANATORY NOTE**

This Order amends the provision of the Parking Places on Roads Order (Northern Ireland) 1988.

The amendments provide for the introduction of parking places on the roads specified in Schedule 1 and for the deletion of the parking places specified in Schedule 2.
