Belfast Cross Harbour Rail Bridge Link Order (Northern Ireland) 1990

Made 29th August 1990 8th October 1990 Coming into operation

WHEREAS the railway undertaking proposes to construct as part of the cross harbour rail bridge link a bridge over the navigable waters of the River Lagan;

AND WHEREAS notice has been published and served in compliance with paragraphs 1 and 2 of Schedule 6 to the Roads (Northern Ireland) Order 1980(a) as applied and modified by section 67I of and Schedule 1A(b) to the Transport Act (Northern Ireland) 1967(c);

AND WHEREAS three objections were received and subsequently withdrawn:

AND WHEREAS the Department has taken into consideration the reasonable requirements of navigation over the waters affected by the proposal;

NOW THEREFORE the Department of the Environment, in exercise of the powers conferred on it by section 67A(2) and (3)(b) of the Transport Act (Northern Ireland) 1967 and of every other power enabling it in that behalf, on application to it by the railway undertaking, makes the following Order:—

Citation and commencement

- 1.—(1) This Order may be cited as the Belfast Cross Harbour Rail Bridge Link Order (Northern Ireland) 1990 and shall come into operation on 8th October 1990.
- (2) In this Order "the map" means Drawing No. D2/01/26 and marked "Belfast Cross Harbour Rail Bridge Link Order (Northern Ireland) 1990" copies of which have been deposited for inspection at Belfast Development Office, Clarendon House, 9-21 Adelaide Street, Belfast BT2 8NR, at Northern Ireland Railways Company Ltd. Belfast Cross Harbour Rail Bridge

Points of commencement and termination

The centre line of the bridge shall extend from a point on the west bank of the River Lagan approximately 280 metres north of the Queen Elizabeth Bridge to a point on the east bank approximately 175 metres north of the Queen Elizabeth Bridge more particularly delineated and hatched red on the map.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order provides for the construction, by the Northern Ireland Railways Company Limited, of a bridge over the navigable waters of the River Lagan, as part of the cross harbour rail link between York Road Station and a point on the railway line between Central Station and Bridge End Station.
