General Dental Services (Amendment) Regulations (Northern Ireland) 1990

. 14th December 1990 Made Coming into operation 1st January 1991

The Department of Health and Social Services, in exercise of the powers conferred by Articles 61, 98, 106 and 107 and Schedule 15 to the Health and Personal Social Services (Northern Ireland) Order 1972(a) and with the approval of the Department of Finance and Personnel(b) in so far as they relate to Schedule 15 to that Order and in conjunction with the Department of Finance and Personnel in so far as they relate to Article 61 of that Order, and of every other power enabling it in that behalf, and after consultation with such organisations as appear to the Department to be representative of the dental profession as required by Article 61(4) of that Order, hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the General Dental Services (Amendment) Regulations (Northern Ireland) 1990 and shall come into operation on 1st January 1991.

Amendment

- 2. The Health and Personal Social Services (General Dental Services) Regulations (Northern Ireland) 1975(c) shall be amended as follows:—
- (1) In paragraph 16(2) of Schedule 1 (terms of service for dentists) for head (i) there shall be substituted the following head:—
 - "(j) palliative treatment that is immediately necessary (including the treatment of sensitive cementum or dentine, stoning or smoothing the surface of a tooth, or the provision of a temporary crown);".

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Health and Personal Social Services (General Dental Services) Regulations (Northern Ireland) 1975.

They enable a dentist to provide as occasional treatment, palliative treatment that is immediately necessary (including the treatment of sensitive cementum or dentine, stoning or smoothing the surface of a tooth, or the provision of a temporary crown). The Health and Personal Social Services (General Dental Services) Regulations (Northern Ireland) 1975 enabled the provision of a temporary crown as an immediately necessary palliative or in an emergency.
