ROAD TRAFFIC AND VEHICLES****Passenger and Goods Vehicles (Recording Equipment) (Fees)
(Amendment) Regulations (Northern Ireland) 1991**

Made 20th March 1991

Coming into operation 1st April 1991

The Department of the Environment, being a department designated(a) for the purpose of section 2(2) of the European Communities Act 1972(b) in relation to the regulation of the type, description, construction or equipment of vehicles and the regulation and supervision of working conditions of persons engaged in road transport, in exercise of the powers conferred on it by section 56(1) and (5) of the Finance Act 1973(c), and of all other powers enabling it in that behalf, and with the approval of the Department of Finance and Personnel(d) as regards regulation 3, makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Passenger and Goods Vehicles (Recording Equipment) (Fees) (Amendment) Regulations (Northern Ireland) 1991 and shall come into operation on 1st April 1991.

Interpretation

2. The Interpretation Act (Northern Ireland) 1954(e) shall apply to these Regulations as it applies to a Measure of the Northern Ireland Assembly.

Regulations amended

3. In regulation 11 (fee for approval or renewal of approval of fitters and workshops) of the Passenger and Goods Vehicles (Recording Equipment) Regulations (Northern Ireland) 1979(f), for—

(1) “£230” substitute “£244”; and

(2) “£93” substitute “£99”.

Revocation

4. The Passenger and Goods Vehicles (Recording Equipment) (Fees) (Amendment) Regulations (Northern Ireland) 1989(g) are revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Passenger and Goods Vehicles (Recording Equipment) Regulations (Northern Ireland) 1979 by increasing the fee for—

- (1) the grant of an approval of a fitter or workshop for the installation or repair of recording equipment (tachographs) from £230 to £244; and
- (2) the renewal of an approval from £93 to £99 (regulation 3).

The Passenger and Goods Vehicles (Recording Equipment) (Fees) (Amendment) Regulations (Northern Ireland) 1989 are revoked as spent.
