Rates (Regional Rate) (Amendment) Order (Northern Ireland) 1991

Coming into operation

1st April 1991

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974.

The Department of Finance and Personnel (a), in exercise of the powers conferred on it by Articles 2(2) and 27(4) of the Rates (Northern Ireland) Order 1977(b) and of every other power enabling it in that behalf, hereby makes the following Order:-

Citation and commencement

1. This Order may be cited as the Rates (Regional Rate) (Amendment) Order (Northern Ireland) 1991 and shall come into operation on 1st April 1991.

Reduction of regional rate on dwellings

2. In Article 3 of the Rates (Regional Rate) Order (Northern Ireland) 1991(c) (which fixes the amount by which the normal regional rate for the year ending 31st March 1992 is to be reduced for the purposes of paragraphs (2) and (3) of Article 27 of the Rates (Northern Ireland) Order 1977) for "12 pence" there shall be substituted "94 pence".

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order amends the Rates (Regional Rate) Order (Northern Ireland) 1991. It increases the amount by which the normal regional rate is reduced in respect of dwelling houses and hereditments which, though not dwelling-houses, are used partly for the purposes of private dwellings from 12 pence to 94 pence.
