### S.R. 1991 No. 163

Order, dated 16th April 1991, made by the Department of the Environment under Articles 2(2) and 40(1)(2) of the Roads (Northern Ireland) Order 1980, authorising the abandonment of an area of approximately 24 square metres of footway in Alton Court extending in a north-westerly direction from a line approximately 15 metres north-west of No. 87 Unity Walk in the City of Belfast

# S.R. 1991 No. 184

Order, dated 30th April 1991, made by the Department of the Environment under Articles 2(2) and 40(1)(2) of the Roads (Northern Ireland) Order 1980, authorising the abandonment of approximately 16 square metres of footway fronting No. 25 Ormeau Avenue in the City of Belfast.
