

**1991 No. 164****LANDS TRIBUNAL****Lands Tribunal (Salaries) Order (Northern Ireland) 1991**

*Made* . . . . . 12th April 1991

*Coming into operation* . . . . . 24th May 1991

*To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974*

In exercise of the powers conferred by section 2(5) of the Lands Tribunal and Compensation Act (Northern Ireland) 1964(a) and section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b), and now vested in me (c) and of all other powers enabling me in that behalf, I hereby make the following Order:

*Title and Commencement*

1. This Order may be cited as the Lands Tribunal (Salaries) Order (Northern Ireland) 1991 and shall come into operation on 24th May 1991.

*Revocation*

2. The Lands Tribunal (Salaries) Order (Northern Ireland) 1990(d) is hereby revoked.

*Increases in Salaries*

3.—(1) The annual salary payable to the President of the Lands Tribunal shall be increased as follows—

- (a) from £58,900 to £63,300 from 1st April 1991;
- (b) from £63,300 to £65,250 from 1st August 1991;
- (c) from £65,250 to £66,500 from 1st December 1991;
- (d) from £66,500 to £68,400 from 1st April 1992.

(2) The annual salary payable to any other member of the Lands Tribunal shall be increased as follows—

- (a) from £53,050 to £57,050 from 1st April 1991;
- (b) from £57,050 to £58,800 from 1st August 1991;
- (c) from £58,800 to £59,900 from 1st December 1991;
- (d) from £59,900 to £61,600 from 1st April 1992.

This Order provides for increases in the annual salaries payable to members of the Lands Tribunal for Northern Ireland following recommendations made in the Report of the Review Body on Top Salaries in 1991 (HMSO Cm 1413).

These increases are made with retrospective effect from 1 April 1991 under Section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.

Article 2 revokes the Lands Tribunal (Salaries) Order (Northern Ireland) 1990.
