

1991 No. 173**SEEDS****Seeds (Fees) Regulations (Northern Ireland) 1991**

Made 25th April 1991

Coming into operation 30th May 1991

The Department of Agriculture, in exercise of the powers conferred on it by sections 1(1), 1(2A)(a), 2(2) and (4) of the Seeds Act (Northern Ireland) 1965(b) and of every other power enabling it in that behalf, after consultation with representatives of such interests as appear to it to be concerned and with the approval of the Department of Finance and Personnel(c) with regard to the licensing fee for licensed testing establishments, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Seeds (Fees) Regulations (Northern Ireland) 1991 and shall come into operation on 30th May 1991.

Revocation

2. The Seeds (Fees) Regulations (Northern Ireland) 1990(d) are hereby revoked.

Fees

3. Subject to the provisions of these Regulations there shall be paid in advance to the Department in respect of matters arising under the Regulations referred to in Schedules 1 to 6 the fees set out in the second column of each of those Schedules opposite the respective references to such matters in the first column of each of those Schedules.

Exemption

4. The Department may exempt any person or class of persons or persons generally from compliance with any of the provisions of these Regulations and the exemptions may be made subject to conditions.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

Regulations controlling the marketing of cereal seeds, fodder plant seeds, beet seeds, oil and fibre plant seeds, and vegetable seeds ("seeds regulations") provide that, with certain exceptions, seeds of these categories may only be marketed if they are derived from crops which on inspection are found to meet certain standards and if upon subsequent testing samples of the seed also meet certain standards.

These Regulations which are made under the Seeds Act (Northern Ireland) 1965 prescribe revised fees for seed certification and licences for seed testing. They supersede the Seeds (Fees) Regulations (Northern Ireland) 1990.

The matters in respect of which the revised fees are prescribed are listed in Schedules 1 to 6 to these Regulations, and the fees which were chargeable before these Regulations came into force are indicated in brackets beside the revised fees.
