# Farm and Conservation Grant (Amendment No. 2) Scheme (Northern Ireland) 1991

Made..<

The Department of Agriculture, in exercise of the powers conferred on it by Article 16(1) and (2) of the Agriculture and Fisheries (Financial Assistance) (Northern Ireland) Order 1987(a) and of every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel, hereby makes the following Scheme:

## Citation, commencement and interpretation

- 1.—(1) This Scheme may be cited as the Farm and Conservation Grant (Amendment No. 2) Scheme (Northern Ireland) 1991 and shall come into operation on 18th July 1991.
  - (2) In this Scheme—
  - "the principal Scheme" means the Farm and Conservation Grant Scheme (Northern Ireland) 1989(b).

## Savings

- 2.—(1) Article 4(b) and (e) of this Scheme shall not apply—
- (a) in relation to any claim for grant under the principal Scheme received by the Department before 18th July 1991, or
- (b) in relation to any claim for grant under the principal Scheme towards expenditure incurred before 18th December 1990,

and those provisions of this Scheme shall not affect the operation of the principal Scheme in relation to any such claim for grant.

(2) Articles 4(a) and (c), 5(2) and 6 of this Scheme shall not apply in relation to any claim for grant received by the Department before 18th July 1991, and those Articles shall not affect the operation of the principal Scheme in relation to any such claim for grant.

## Amendment to the principal Scheme

3. Subject to Article 2 the principal Scheme shall be amended in accordance with Articles 4, 5 and 6.

- 4. In Article 2 (interpretation)—
- (a) after the definition of "agricultural business" there shall be inserted the following definition:
  - " "beneficial organism" means any creature bred or kept for its use in the control of infestation of horticultural produce by pests;";
- (b) in the definition of "designated maps" for "4th April 1984" there shall be substituted "8th May 1991";
- (c) in the definition of "glasshouse", after the words "horticultural produce" there shall be inserted "or beneficial organisms";
- (d) in the definition of "improvement plan" after "1987" "or" shall be omitted and after "1989" there shall be inserted "or the Farm and Conservation Grant Regulations (Northern Ireland) 1991;"(a); and
- (e) for sub-paragraph (a) of the definition of "less-favoured area", there shall be substituted the following sub-paragraph:
  - "(a) which is situated in an area included in the list of less-favoured farming areas adopted by the Council or the Commission of the European Communities under Article 2(2) of Council Directive 75/268/EEC(b) on mountain and hill farming and farming in certain less favoured areas, as amended by Council Directive 80/666/EEC(c), which list is contained in Council Directive 84/169/EEC(d), as amended by Commission Decision 91/25/ EEC(e), and".
- **5.**—(1) In Article 4(1) (restrictions on payment of grant)—
- (a) in sub-paragraph (d), for the words from "reference quantity" to the end of the sub-paragraph there shall be substituted the following:
  - "quota, as defined in the Dairy Produce Quotas Regulations 1989(f), of the person carrying on the agricultural business to which the expenditure relates"; and
- (b) in sub-paragraph (e)(i), for the words "ancillary farm business" there shall be substituted "qualifying business".
- (2) In Article 4(3), for the figure "£35,000" there shall be substituted "£42,500", and for the figure "£74,000" there shall be substituted "£85,000".
  - (3) In Article 4(5)—
  - (a) there shall be inserted the following definition:
    - " "qualifying business" means a business consisting in the pursuit of a qualifying activity where that business is carried on by the person also carrying on the eligible agricultural business on the same or adjacent land;"; and
  - (b) the definition of "ancillary farm business" shall be omitted.

**6.** In the Schedule (eligible works, facilities and transactions and rates of grant), in paragraphs 7 and 8 in column 1, after the words "horticultural produce" in each place, there shall be inserted "or beneficial organisms".

### EXPLANATORY NOTE

(This note is not part of the Scheme.)

This Scheme further amends the Farm and Conservation Grant Scheme (Northern Ireland) 1989 ("the principal Scheme") and complies with Article 8 of Council Regulation (EEC) No. 797/85 (O.J. No. L93, 30.3.85, p. 1) on improving the efficiency of agricultural structures, as amended by Council Regulations (EEC) No. 1760/87 (O.J. No. L167, 26.6.87, p. 1), 2156/89 (O.J. No. L207, 19.7.89, p. 12) and 3808/89 (O.J. No. L93, 30.3.85, p. 1).

### The Scheme-

- (a) provides for grant in respect of glasshouses used for the production of "beneficial organisms" intended for pest control (Articles 4(a) and (c) and 6);
- (b) extends the areas of land which may be treated for the purposes of the principal Scheme as less-favoured areas, in which higher rates of grant are payable, in accordance with Commission Decision 91/25/EEC (O.J. No. L16, 22.1.91, p. 25), which amends the list of less-favoured farming areas contained in Council Directive 84/169/ EEC (O.J. No. L82, 26.3.84, p. 67) (Article 4(d)). Less-favoured areas are defined by reference to designated maps which are available for inspection during normal office hours at the offices of the Department at Dundonald House, Upper Newtownards Road, Belfast BT4 3SB. Copies of the maps may also be inspected during normal office hours at any County Agricultural Development Office or selected Area Offices of the Department of Agriculture for Northern Ireland. This amendment of the principal Scheme does not apply to claims for grant received before 18th July 1991 or claims towards expenditure incurred before 18th December 1990, the date of notification of the Commission Decision;
- (c) makes increases in the maximum limits of expenditure which may be eligible for grant (Article 5(2)).

#### The Scheme also—

- (a) makes the restriction on expenditure in connection with the breeding or keeping of dairy cows referable to an applicant's quota, as defined in the Dairy Produce Quotas Regulations 1989 (Article 5(1)(a)); and
- (b) replaces the term "ancillary farm business" with "qualifying business" (Article 5(1)(b) and (3)).
- (c) extends the definition of "improvement plan" to include the Farm and Conservation Grant Regulations (Northern Ireland) 1991. (Article 4(d)).
