Angling (Department of Agriculture Waters) (Temporary Amendment) Byelaws (Northern Ireland) 1991

The Fisheries Conservancy Board for Northern Ireland in exercise of its powers under section 26(1) of the Fisheries Act (Northern Ireland) 1966(a) and of every other power enabling it in that behalf with the approval of the Department of Agriculture hereby makes the following Byelaws:

Citation and commencement

1. These Byelaws may be cited as the Angling (Department of Agriculture Waters) (Temporary Amendment) Byelaws (Northern Ireland) 1991 and shall come into operation on 1st September 1991.

Interpretation

2. In these Byelaws—

"Coarse fish" means freshwater fish other than trout and rainbow trout.

Amendments

- 3. Subject to Byelaw 4 there shall be substituted for Byelaw 7 of the Angling (Department of Agriculture Waters) Byelaws (Northern Ireland) 1989(b) the following:—
 - "7. The prohibition imposed by Byelaw 6 shall not apply on the River Ballinamallard, River Blackwater, the Quoile Basin, Upper Lough Erne, in that part of Lower Lough Erne to the east of an imaginary line running approximately south west from the point where the A47 Road from Belleek to Boa Island leaves the mainland in the townland of Tawnawanny, touching the most westerly point of Binghams Rock and the most easterly part of Hills Island and on to where it meets the southern shore in the townland of Drumcrow West or in that part of the River Erne running from the mouth of the river immediately west of Marker Buoy 58A in Lough Erne to a point 750 metres downstream of the Rosscor Viaduct".
- **4.** Subject to Byelaw 4 in the Schedule to the Angling (Department of Agriculture Waters) Byelaws (Northern Ireland) 1989 there shall be substituted for the entry for River Erne the following:—

"River Erne

(a) from the mouth of the river immediately west of Marker Buoy 58A in Lough Erne to a point 750 metres downstream of the Rosscor Viaduct

All lawful methods

For coarse fish—None
For game fish—six fish with a minimum length of 30.0 cm.

(b) All other parts

From the shore fly fishing, spinning and worm fishing. From boats fly fishing

only

Six fish with a minimum length of length of 30.0 cm."

Duration and expiry

5. These Byelaws have effect from 31st August 1991 to 30th November 1991 and from 14th June 1992 to 6th September 1992.

EXPLANATORY NOTE

(This note is not part of the Byelaws.)

These Byelaws amend the Angling (Department of Agriculture Waters) Byelaws (Northern Ireland) 1989 in order to allow coarse angling and the use of ground bait and maggots, other than spinning, on that part of the River Erne which lies between the point where Lower Lough Erne discharges into the River and a point 750 metres downstream of Rosscor Viaduct, from 1st September 1991 to 30th November 1991 inclusive and from 15th June 1992 to 6th September 1992 inclusive.
