Seed Potatoes (Tuber and Label Fees) (Amendment)
Regulations (Northern Ireland) 1991

Made 15th August 1991

Coming into operation 23rd September 1991

The Department of Agriculture, in exercise of the powers conferred on it by section 1(1), (2) and (2A) of the Seeds Act (Northern Ireland) 1965(a) and of every other power enabling it in that behalf, after consultation with representatives of such interests as appear to it to be concerned, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 1991 and shall come into operation on 23rd September 1991.

Revocation

2. The Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 1990(b) are hereby revoked.

Amendment of the Seed Potatoes (Tuber and Label Fees) Regulations (Northern Ireland) 1982

3. For the Schedule to the Seed Potatoes (Tuber and Label Fees) Regulations (Northern Ireland) 1982(c) there shall be substituted:

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations revoke and replace the Seed Potatoes (Tuber and Label Fees) (Amendment) Regulations (Northern Ireland) 1990.

The Regulations:—

- (1) increase the fee payable for the inspection of seed potatoes prior to their being sealed under regulation 9(2) of the Seed Potatoes Regulations (Northern Ireland) 1981 from £2·85 per tonne or part of a tonne to £3·10 per tonne or part of a tonne;
- (2) leave unchanged the fees for the provision of official documents and official labels.
