Article 19(3) inserts sub-paragraph (1A) into paragraph 5 of Schedule 1 to the principal Act. That sub-paragraph is amended by Article 4(3)(b) of the Social Security (Contributions) (Northern Ireland) Order 1991 (S.I. 1991/2294 (N.I. 22)); by virtue of Article 1(3) of that Order that amendment also comes into operation on 6th April 1992.
