### The Social Security (Credits) (Amendment) Regulations (Northern Ireland) 1992

The Department of Health and Social Services for Northern Ireland, in exercise of the powers conferred on it by section 13(4) of the Social Security (Northern Ireland) Act 1975(a) and of all other powers enabling it in that behalf, hereby makes the following regulations:

#### Citation, commencement and interpretation

**1.**—(1) These regulations may be cited as the Social Security (Credits) (Amendment) Regulations (Northern Ireland) 1992 and shall come into operation on 6th April 1992.

(2) In these regulations "the principal regulations" means the Social Security (Credits) Regulations (Northern Ireland) 1975(b).

# Amendment of regulation 9 of the principal regulations

2. In regulation 9 of the principal regulations (credits for unemployment or incapacity for work)—

(a) in paragraph (3) after "paragraphs" there shall be inserted "(3A),";

(b) after paragraph (3) there shall be inserted the following paragraph—

"(3A) For the purposes of paragraph (3), "day of unemployment" shall also include a day which, by virtue of regulation 7(1)(d) or (k)(iii) of the Social Security (Unemployment, Sickness and Invalidity Benefit) Regulations (Northern Ireland) 1984(c), is not to be treated as a day of unemployment for the purposes of unemployment benefit, but only if the person concerned furnishes to the Department notice in writing of the grounds on which he claims to be entitled to be credited with earnings, and he does so before the end of the benefit year immediately following the year in which that day falls or within such further time as may be reasonable in the circumstances of his case."

### EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations further amend the Social Security (Credits) Regulations (Northern Ireland) 1975 to provide, on written notice of the grounds of claim, for the crediting of earnings to certain persons who have received compensation following the termination of their employment. They make in relation to Northern Ireland only provision corresponding to provision contained in regulations made by the Secretary of State for Social Security in relation to Great Britain and accordingly, by virtue of section 10(2) of, and paragraph 21 of Schedule 3 to, the Social Security Act 1980 (c. 30), are not subject to the requirement of section 10(1) of that Act for prior reference to the Social Security Advisory Committee.
