The Department of Education, in exercise of the powers conferred on it by Articles 69(1) and (2) and 134(1) of the Education and Libraries (Northern Ireland) Order 1986(a) and section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962(b) and of every other power enabling it in that behalf, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Colleges of Education (Salaries) (Amendment) Regulations (Northern Ireland) 1992 and shall come into operation on 31st March 1992 and shall have effect on and from 1st September 1991.

Amendment of the Colleges of Education (Salaries) Regulations (Northern Ireland) 1990

2. The Colleges of Education (Salaries) Regulations (Northern Ireland) 1990(c) shall be amended as follows:-

- (1) for the table in paragraph 1 of Schedule 1 there shall be substituted the table set out in Schedule 1 to these Regulations;
- (2) for paragraph 1, Part I of Schedule $2(\mathbf{d})$ there shall be substituted the paragraph set out in Schedule 2 to these Regulations.

SCHEDULE 2

Transfer to Revised Scales of Salaries

"1. A lecturer who on 1st September 1991 was, and had immediately before that date been, employed in the same capacity in a college of education, shall from that date be transferred to the appropriate scale in Schedule 1 at the point on the scale corresponding to that on which he would have received salary had the scale previously in operation on 1st September 1991 continued to apply."

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Colleges of Education (Salaries) Regulations (Northern Ireland) 1990 and give effect, from 1st September 1991, to an increase of 5% in salaries for lecturers in colleges of education.

Regulation 2(1) and Schedule 1 set out the revised scales of salaries.

These Regulations have retrospective effect by virtue of section 18 of the Administrative and Financial Provisions Act (Northern Ireland) 1962.
