The Social Security (Class 1 Contributions — Contracted-out Percentages) Order (Northern Ireland) 1992

Whereas the Secretary of State for Social Security has made an order(a) under section 28 of the Social Security Pensions Act 1975(b):

Now, therefore, the Department of Health and Social Services, in exercise of the powers conferred on it by Article 30 of the Social Security Pensions (Northern Ireland) Order 1975(c) and of all other powers enabling it in that behalf, hereby makes the following order:

Citation and commencement

1. This order may be cited as the Social Security (Class 1 Contributions - Contracted-out Percentages) Order (Northern Ireland) 1992 and shall come into operation on 6th April 1993.

Alteration of contracted-out rates of Class 1 contributions

2. In the definition of "the contracted-out percentage" contained in Article 29(2) of the Social Security Pensions (Northern Ireland) Order 1975(d) the following alterations shall be made—

(a) in paragraph (a) for "2.0" there shall be substituted "1.8"; and

(b) in paragraph (b) for " $3\cdot 8$ " there shall be substituted " $3\cdot 0$ ".

Consequential provision

3. In paragraph 2(2) of Schedule 4 to the Social Security Pensions (Northern Ireland) Order 1975(e) (priority in bankruptcy: employer's contributions to an occupational pension scheme), so far as the percentages specified in that paragraph apply in relation to earnings paid or payable as from 6th April 1993 the following alterations shall be made-

4. The Social Security (Class 1 Contributions — Contracted-out Percentages) Order (Northern Ireland) 1987(a) is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Order.)

This order, which corresponds to an order (S.I. 1992/795) made by the Secretary of State for Social Security under section 28 of the Social Security Pensions Act 1975, decreases, with effect from 6th April 1993, the contracted-out percentages to be deducted from the normal percentage for both primary and secondary Class 1 contributions under Article 29 of the Social Security Pensions (Northern Ireland) Order 1975. Consequential changes are also made to paragraph 2(2) of Schedule 4 to that Order (priority in bankruptcy — employer's contribution to an occupational pension scheme).
