The Fisheries Conservancy Board for Northern Ireland, in exercise of the powers conferred on it by section 26(1) of the Fisheries Act (Northern Ireland) $1966(\mathbf{a})$ and of every other power enabling it in that behalf, with the approval of the Department of Agriculture hereby makes the following Byelaws:

Citation and commencement

1. These Byelaws may be cited as the Licence Holders (Dealer's Register) Byelaws (Northern Ireland) 1992 and shall come into operation on 13th April 1992.

Form of dealer's register

2. The form of register, required to be kept under section 120(1) of the Fisheries Act (Northern Ireland) 1966(b) by every holder of a dealer's licence, shall be in the form prescribed in the Schedule and shall contain the particulars prescribed therein.

Fisheries EXPLANATORY NOTE

(This note is not part of the Byelaws.)

These Byelaws prescribe the form of register to be kept by every holder of a dealer's licence and the particulars to be recorded therein in relation to the purchases and sales of salmon, trout, eels, pike or pollen.
