The Statutory Sick Pay (Rate of Payment) Order (Northern Ireland) 1992

The Department of Health and Social Services, in exercise of the powers conferred on it by Article 9(1A)(a) of the Social Security (Northern Ireland) Order 1982(**a**) and of all other powers enabling it in that behalf, hereby makes the following order:

Citation, commencement and interpretation

1.—(1) This order may be cited as the Statutory Sick Pay (Rate of Payment) Order (Northern Ireland) 1992 and shall come into operation on 6th April 1992, immediately after the coming into operation of Article 9 of the Social Security Benefits Up-rating Order (Northern Ireland) 1992(b).

(2) In this order "the Order" means the Social Security (Northern Ireland) Order 1982.

Substitution of provisions in Article 9(1) of the Order

2. In Article 9(1) of the Order(c) for sub-paragraphs (a) and (b) there shall be substituted the following sub-paragraphs—

- "(a) $\pounds 52.50$, in a case where the employee's normal weekly earnings under his contract of service with that employer are not less than $\pounds 190$; or
 - (b) $\pounds 45.30$, in any other case.".

Transitional provisions

3. Where in relation to statutory sick pay a period of entitlement as between an employer and an employee is running at 6th April 1992 and the employee's normal weekly earnings under his contract of service with that employer are not less than, or are treated for the purposes of Article 9(1) of the Order as not less than, ± 185 they shall be treated for the purposes of that Article as not less than ± 190 for the remainder of that period.

EXPLANATORY NOTE

(This note is not part of the Order.)

This order, which comes into operation on 6th April 1992, substitutes alternative provisions for the sub-paragraphs of paragraph (1) of Article 9 of the Social Security (Northern Ireland) Order 1982 (rate of payment). The new provisions increase the lower rate of statutory sick pay from £43.50 to £45.30 per week. The higher rate remains unchanged at £52.50 per week. In addition the earnings band is altered so that the higher rate becomes payable where the employee's earnings are normally £190 or more per week (increased from £185 or more per week) (Article 2).

Article 3 contains transitional provisions for those employees who are incapable of work at the time of the change and would otherwise move from the higher to the lower rate of statutory sick pay.

This order makes in relation to Northern Ireland only provision corresponding to provision contained in an order made by the Secretary of State for Social Security in relation to Great Britain and accordingly, by virtue of section 10(2) of, and paragraph 21 of Schedule 3 to, the Social Security Act 1980 (c. 30), is not subject to the requirement of section 10(1) of that Act for prior reference to the Social Security Advisory Committee.
