# County Court (Amendment No. 5) Rules (Northern Ireland) 1992

Made . . . . . . . . . 10th December 1992 Coming into operation . . . 1st January 1993

We, the County Court Rules Committee, appointed by the Lord Chancellor under Article 46 of the County Courts (Northern Ireland) Order 1980(a), in exercise of the powers conferred on us by Article 47 of that Order, hereby make the following rules:—

## Citation and interpretation.

- 1.—(1) These rules may be cited as the County Court (Amendment No. 5) Rules (Northern Ireland) 1992.
- (2) In these rules a reference to an Order, Rule or Form is a reference to that Order, Rule or Form as numbered in the County Court Rules (Northern Ireland) 1981(b).

## Licensing

- 2.—(1) Order 48 shall be amended as follows:—
- (a) in paragraph (1) of Rule 3, by deleting the words from "registered" to "that Act" and substituting the words "premises of any establishment allocated by a certificate under Article 13 of the Tourism (Northern Ireland) Order 1992(c) to the statutory category of hotel shall be given at the hearing of the application by production of a certificate to that effect issued by the Northern Ireland Tourist Board";
- (b) in paragraph (2) of Rule 3, by deleting the words "registration and" and "and purporting to be so authenticated";
- (c) in paragraph (3) of Rule 3, by deleting the words from "the certificate" to "1948" and substituting the words "in relation to premises of a kind mentioned in Article 6(1)(a), the certificate referred to in Article 50(7)(c) issued by the Northern Ireland Tourist Board.".
- (2) Form 196 shall be amended, in the first paragraph, by deleting the words from "which are" to "1948" and substituting the words "of any establishment which is [or is intended to be] allocated by a certificate under

Article 13 of the Tourism (Northern Ireland) Order 1992 to the statutory category of hotel'.

(3) Form 197 shall be amended by deleting sub-paragraph (i) of paragraph (b).

#### EXPLANATORY NOTE

(This note is not part of the rules.)

These rules amend the licensing provisions in the County Court Rules (Northern Ireland) 1981 to take account of the changes in tourism and licensing legislation effected by the Tourism (Northern Ireland) Order 1992 [S.I. 1992/235 (N.I. 3)]. References in the licensing provisions to tourism legislation are either updated to refer to the 1992 Order or deleted because they are no longer applicable.
