**Police and Criminal Evidence (1989 Order)  
(Commencement No. 3) Order (Northern Ireland) 1993**

In exercise of the powers conferred on me by Article 1(3) of the Police and Criminal Evidence (Northern Ireland) Order 1989(a), I hereby make the following Order:—

*Citation*

1. This Order may be cited as the Police and Criminal Evidence (1989 Order) (Commencement No. 3) Order (Northern Ireland) 1993.

*Appointed day*

2. The day appointed for the coming into operation of the provisions of the Police and Criminal Evidence (Northern Ireland) Order 1989 specified in the Schedule shall be 1st February 1993.

**Provisions of the Police and Criminal Evidence (Northern Ireland) Order  
1989 coming into operation on 1st February 1993**

Article 86 and Schedule 4	Service of summons, etc. by post

**EXPLANATORY NOTE***(This note is not part of the Order.)*

This Order brings into operation on 1st February 1993 Article 86 of and Schedule 4 to the Police and Criminal Evidence (Northern Ireland) Order 1989 which facilitate the service of summonses and certain other documents by post.

**NOTE AS TO EARLIER COMMENCEMENT ORDERS***(This note is not part of the Order)*

Articles 1, 2, 29(4), 60(a), 65, 66 and 89 of the Police and Criminal Evidence (Northern Ireland) Order 1989 ("the 1989 Order") came into operation in accordance with Article 1(2) of the 1989 Order. The remaining provisions of the 1989 Order, with the exception of Article 60(b) and the provisions commenced by this Order, have been brought into operation before the date of this Order by S.R. 1989 No. 404 (C. 15) and S.R. 1989 No. 441 (C. 17).
