# The Local Government (General Grant) Order (Northern Ireland) 1993

Made 9th March 1993 4th May 1993 Coming into operation

To be laid before Parliament under paragraph 3(3) of Schedule 1 to the Northern Ireland Act 1974

The Department of the Environment, in exercise of the powers conferred by paragraph 3(1) of Part I of Schedule 1 to the Local Government &c. (Northern Ireland) Order 1972(a) and now vested in it(b) and of every other power enabling it in that behalf, hereby makes the following Order:

### Citation and commencement

1. This Order may be cited as the Local Government (General Grant) Order (Northern Ireland) 1993 and shall come into operation on 4th May 1993.

# General grant

2. For the purpose of paragraph 3(1) of Part I of Schedule 1 to the Local Government &c. (Northern Ireland) Order 1972 the districts specified for the year ending 31st March 1994 shall be the districts listed below—
