The Occupational and Personal Pension Schemes (Miscellaneous **Amendments) Regulations (Northern Ireland) 1993**

18th March 1993 Made 6th April 1993 Coming into operation

The Department of Health and Social Services, in exercise of the powers conferred on it by Articles 47(1)(b) and 58A(1) of the Social Security Pensions (Northern Ireland) Order 1975(a) and Article 5(5)(a) and (cc) of the Social Security (Northern Ireland) Order 1986(b) and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation and commencement

1. These regulations may be cited as the Occupational and Personal Pension Schemes (Miscellaneous Amendments) Regulations (Northern Ireland) 1993 and shall come into operation on 6th April 1993.

Amendment of the Occupational Pension Schemes (Contracting-out) Regulations

- 2. Regulation 21 of the Occupational Pension Schemes (Contracting-out) Regulations (Northern Ireland) 1985(c) (alternative to limited revaluation premium) shall be amended in accordance with paragraphs (a) to (e)—
 - (a) in paragraph (3)—
 - (i) "Subject to paragraph (3A)," shall be omitted;
 - (ii) for "81/2 per cent. compound" there shall be substituted "the appropriate percentage";
 - (b) paragraph (3A) shall be omitted;

- (c) in paragraph (7)—
 - (i) "Subject to paragraph (7A)," shall be omitted;
 - (ii) for "8½ per cent. compound" there shall be substituted "the appropriate percentage";
- (d) paragraph (7A) shall be omitted;
- (e) after paragraph (7) there shall be added the following paragraph—
 - "(8) In this regulation "the appropriate percentage" in relation to each period of service in respect of which accrued rights to guaranteed minimum pension have been acquired under, or transferred to, the scheme means—
 - (a) where that period of service terminated before 6th April 1988, 8½ per cent. compound;
 - (b) where that period of service terminated on or after 6th April 1988 but before 6th April 1993, 7½ per cent. compound;
 - (c) where that period of service terminates on or after 6th April 1993, 7 per cent. compound.".

Amendment of the Personal Pension Schemes (Disclosure of Information) Regulations

3. In Schedule 2 to the Personal Pension Schemes (Disclosure of Information) Regulations (Northern Ireland) 1987(a) at the end of paragraph 1 (information about contributions to be made available to individuals) there shall be added-

(c) Article 5(1)(aa) of that Order(b)".

Amendment of the Personal Pension Schemes (Appropriate Schemes) Regulations

- 4. The Personal Pension Schemes (Appropriate Schemes) Regulations (Northern Ireland) 1988(c) shall be amended in accordance with paragraphs (a) and (b)—
 - (a) in regulation 17(4) (calculation or estimation of earnings), after "Article 5(1)(a)" there shall be inserted "and (aa)";
 - (b) after regulation 17 there shall be inserted the following regulation—

"Calculation of Minimum contributions

17A. For the purposes of determining whether any minimum contribution which may be payable to or for the benefit of an earner should include an amount calculated under Article 5(1)(aa) of the Order, the Department may serve a notice in writing on the earner in question which—

- (a) requires him to send documentary evidence of the date of his birth to the Department; and
- (b) sets out the address to which that evidence is to be sent.".

Revocation

5. Regulation 2(6) and (8) of the Contracting-out (Miscellaneous Amendments) Regulations (Northern Ireland) 1988(a) is hereby revoked.

Social Security EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations further amend the following sets of regulations.

- (a) The Occupational Pension Schemes (Contracting-out) Regulations (Northern Ireland) 1985 which are amended so that, where contracted-out employment ceases the fixed rate of revaluation of accrued rights to guaranteed minimum pension will be the "appropriate percentage". In respect of a period of contracted-out employment which ceases on or after 6th April 1993 the appropriate percentage will be 7% (regulation 2).
- (b) The Personal Pension Schemes (Disclosure of Information) Regulations (Northern Ireland) 1987 which are amended so as to require, as part of the information to be made available to individuals, disclosure of the amount of the minimum contributions attributable to the 1% addition under Article 5(1)(aa) of the Social Security (Northern Ireland) Order 1986 (regulation 3).
- (c) The Personal Pension Schemes (Appropriate Schemes) Regulations (Northern Ireland) 1988 which are amended by making provision in respect of the calculation of earnings and the verification of age for the purposes of determining the amount of any payment under Article 5(1)(aa) of the Social Security (Northern Ireland) Order 1986 (regulation 4).

The regulations also contain a consequential revocation.
