INDUSTRIAL ASSURANCE

Industrial Assurance (Fees) Regulations (Northern Ireland) 1993

Made . . . . . 5th April 1993

Coming into operation . . . . . 10th May 1993

The Department of Economic Development, in exercise of the powers conferred by Article 49(1) of the Industrial Assurance (Northern Ireland) Order 1979(a) and now vested in it(b) and of every other power enabling it in that behalf, with the approval of the Department of Finance and Personnel(c), hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Industrial Assurance (Fees) Regulations (Northern Ireland) 1993 and shall come into operation on 10th May 1993.

Fees

2. The fees set out in the Schedule shall be payable to the Department of Economic Development in respect of the matters specified therein.

Revocation

3. The Industrial Assurance (Fees) Regulations (Northern Ireland) 1991(d) are hereby revoked.

### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations supersede the Industrial Assurance (Fees) Regulations (Northern Ireland) 1991.

The Regulations generally increase by between 4% and 10% the fees to be paid for matters transacted or arising under the Industrial Assurance (Northern Ireland) Order 1979 and for the inspection, or furnishing of copies, of documents in the custody of the Commissioner. However, the fee for the provision of a photocopy of the whole of or an extract from a document held on a public file has increased by 25%. There has been no increase in the fee for a direction of the Commissioner for the division or appropriation of the assets of a society or for an application under Article 36(3) of the Order.
