**Foyle Area (Licensing of Fishing Engines)
(Amendment) Regulations 1993**

Made 7th December 1993

Coming into operation 24th January 1994

The Foyle Fisheries Commission in exercise of its powers under section 13(1) and (2) of the Foyle Fisheries Act 1952(a), and section 13(1) and (2) of the Foyle Fisheries Act (Northern Ireland) 1952(b), with the approval of the Minister for the Marine in the Republic of Ireland(c) and of the Department of Agriculture for Northern Ireland(d), hereby makes the following Regulations:—

Citation and commencement

1. These Regulations may be cited as the Foyle Area (Licensing of Fishing Engines) (Amendment) Regulations 1993 and shall come into operation on 24th January 1994.

Amendment to the Foyle Area (Licensing of Fishing Engines) Regulations 1976

2. There shall be substituted for the Schedule to the Foyle Area (Licensing of Fishing Engines) Regulations 1976(e), the following Schedule:—

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Foyle Area (Licensing of Fishing Engines) Regulations 1976 by increasing the licence fees payable in 1994 in respect of each type of net used and game fishing licence issued in the Foyle Area by the following amounts and also by introducing a new category of game fishing rod and line licence valid for one day.
