Royal Ulster Constabulary Reserve (Full-Time) (Appointment and Conditions of Service) (Amendment No. 2) **Regulations 1994**

9th May 1994 Made 1st July 1994 Coming into operation

To be laid before Parliament

The Secretary of State, in pursuance of section 26 of the Police Act (Northern Ireland) 1970(a), and after consulting, in accordance with section 34(2) of that Act, the Police Authority and the Police Association, hereby with the concurrence of the Treasury makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Royal Ulster Constabulary Reserve (Full-Time) (Appointment and Conditions of Service) (Amendment No. 2) Regulations 1994 and shall come into operation on 1st July 1994.

Interpretation

2. In these regulations any reference to the principal regulations is a reference to the Royal Ulster Constabulary Reserve (Full-Time) (Appointment and Conditions of Service) Regulations 1988(b).

Meanings assigned to certain expressions

- 3. In regulation 3(1) of the principal regulations there shall be inserted after the words "assigned to them:—" the following definition:—
 - "Central Committee" has the meaning assigned to it in regulation 14 of the Police Association for Northern Ireland Regulations 1991(c);".

Qualifications for appointment to the force

4. Paragraph (d) of regulation 11(1) shall be omitted.

Variable shift arrangements

5. In the principal regulations there shall be inserted after regulation 21 the following paragraph:—

"Variable shift arrangements

- **21A.**—(1) This regulation applies to members below the rank of superintendent.
- (2) Subject to the consent of the Secretary of State the chief constable may bring into operation variable shift arrangements agreed by him with the Central Committee for all members to whom this regulation applies or for any particular class of such members.
- (3) Variable shift arrangements must provide, as respects members for whom they are in operation—
 - (a) for hours of duty equivalent to those resulting from the application of regulations 20(1) and 23(1), and
 - (b) for annual leave equivalent to that resulting from the application of regulation 25(1) and Schedule 2,

to other members of the force.

(4) In relation to members for whom variable shift arrangements are in operation these regulations have effect with the modifications set out in Schedule 1A.".

Modification for variable shift arrangements

6. In the principal regulations there shall be inserted after Schedule 1 the schedule set out in Schedule 1 to these regulations.

Annual leave

7. There shall be substituted for paragraph 1 of Schedule 2 to the principal regulations and the Table contained therein the paragraph and Table set out in Schedule 2 to these regulations.

Schedule inserted after Schedule 1 to the principal regulations

"SCHEDULE 1A

Regulation 21A

Modification for variable shift arrangements

- 1. In regulation 20 (normal daily period of duty) there shall be substituted for paragraphs (1) to (3) the following paragraphs:—
 - "(1) So far as the exigencies of duty permit, a shift shall consist of one continuous period.
 - (2) Where in one day a member is on duty for a continuous period of 5 hours of more, time for refreshment shall, as far as the exigencies of duty permit, be allowed in accordance with the table below:

Number of hours	Refreshment time 30 minutes	
Less than 6 hours		
6 hours or more, but less than 7 hours	35 minutes	
7 hours or more, but less than 8 hours	40 minutes	
8 hours or more, but less than 9 hours	45 minutes	
9 hours or more, but less than 10 hours	50 minutes	
10 hours or more	60 minutes	

- (3) Where a shift consists of two periods amounting in total to 5 hours or more and the member does not travel to and from his home between those periods, an interval for refreshment and rest shall normally be included at the beginning or end of one of them.".
- 2. In regulation 21 (rostering of duties)—
- (a) in paragraph (1) omit the word "annual";
- (b) in paragraph (4)—
 - (i) for the words "the 12 months following the date on which it comes into force" substitute "the period for which it has effect", and
 - (ii) in sub-paragraph (c) for the words "his scheduled daily periods of duty are" substitute "each of his shifts is";
- (c) in sub-paragraph (5)(a) for the words "daily periods of duty" substitute "shifts"; and
- (d) in paragraph (6) for the words "daily period of duty" substitute "shift".
- 3. In regulation 22 (overtime)—
- (a) in paragraph (1)—
 - (i) for the words "his tour of duty" substitute "a rostered shift",
 - (ii) for the words "tours of duty" substitute "rostered shifts", and
 - (iii) for the words "a tour of duty" and for the words "his normal daily period of duty" substitute "a rostered shift";
- (a) in paragraph (6) for the word "tour", wherever occurring, substitute "shift";
- (c) omit paragraph (7)(b);

- (d) in paragraph (7)(c) for the words "tours of duty" substitute "shifts";
- (e) in paragraph (7)(d)—
 - (i) for the words "a rostered tour of duty" substitute "a rostered shift",
 - (ii) for the words "begin that tour" substitute "begin that shift",
 - (iii) for the words "his normal daily period of duty" substitute "a rostered shift", and
 - (iv) for the words "that tour of duty" substitute "that shift"; and
- (f) in paragraph (8) in the definition of "due notice" for the words "tour of duty" substitute "shift".
- 4. In regulation 23 (public holidays and rest days) in paragraph (2) after the words "the rate of" insert "not less than".
 - 5. In regulation 24 (travelling time treated as duty) for paragraph (1) substitute—
 - "(1) This regulation applies to a member where—
 - (a) a shift consists of two separate periods, or
 - (b) he is recalled to duty between two shifts,

and he travels to and from his home between those periods or, as the case may be, in consequence of his recall (in this regulation referred to as "relevant travelling")."

- 6. In regulation 25 (annual leave) omit paragraph (1).
- 7. In regulation 41 (subsistence, refreshment and lodging allowances) at the end of paragraph (3) insert ", and references in this regulation to a member's normal daily period of duty are to be construed as references to a rostered shift".
- 8. In regulation 48 (allowance for recurring escort duty, etc) for the words "beyond the normal daily period" substitute "after rostered shifts".
 - 9. Omit Schedule 2."

No. 187 Regulation 7

Paragraph and Table substituted for paragraph 1 in Schedule 2 to the principal regulations and the Table contained therein with effect from 1st April 1994

- "1. Subject to regulation 25 and the provisions of this Schedule every member shall be granted in each leave year the period of annual leave in the following table—
 - (a) where he has completed less than 5 years' service, in the first column thereof:
 - (b) where he has completed 5 but has not completed 10 years' service, in the second column thereof;
 - (c) where he has completed 10 but not completed 15 years' service, in the third column thereof;
 - (d) where he has completed 15 but has not completed 20 years' service, in the fourth column thereof;
 - (e) where he has completed 20 or more years' service, in the fifth column thereof.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Royal Ulster Constabulary Reserve (Full-Time) (Appointment and Conditions of Service) Regulations 1988 (the principal regulations) for the purpose of providing for variable shift arrangements, removing the minimum height requirements for appointment to the force, and increasing annual leave entitlement.

Regulation 3 gives the same meaning to "Central Committee", referred to in regulation 5, as in the Police Association for Northern Ireland Regulations 1991, ie comprising representatives of inspectors, sergeants and constables who have been elected to regional boards.

Regulation 4 removes the minimum height requirements for appointment to the force.

Regulation 5 provides that the chief constable may, with the agreement of the Police Federation Central Committee and the approval of the Secretary of State, introduce variable shift arrangements. Such arrangements shall apply only to members of the force below the rank of superintendent and may apply to all members below that rank or to a particular class. The arrangements must provide for hours of duty and annual leave equivalent to those members working a normal shift pattern.

Regulation 6 inserts a new Schedule 1A into the principal regulations. The Schedule sets out the modifications to the principal regulations that shall apply to members operating a variable shift arrangement. In particular paragraphs 1, 6 and 9 disapply the provisions of the principal regulations relating to the normal (8 hour) daily period of duty and to annual leave. Paragraph 2 provides for a more flexible system of duty rosters. Paragraphs 3, 4, 5, 7 and 8 relate to overtime payments, rest days, travelling time, subsistence allowance and escort duty allowance.

Regulation 7 substitutes a new Table of annual leave for the Table in Schedule 2 to the principal regulations. The effect of the amendment is to increase the existing leave entitlement of members and to introduce a new band of leave entitlement for members with 20 or more years' service.
