REGISTRATION OF CLUBS

The Registration of Clubs (Required Information) (Amendment) Regulations (Northern Ireland) 1994

. 15th September 1994 Made 24th October 1994 Coming into operation

The Department of Health and Social Services, in exercise of the powers conferred on it by paragraph 2(2) of Schedule 2 and paragraph 2(2) of Schedule 3 to the Registration of Clubs (Northern Ireland) Order 1987(a) and of all other powers enabling it in that behalf, hereby makes the following regulations:

Citation, commencement and interpretation

- 1.—(1) These regulations may be cited as the Registration of Clubs (Required Information) (Amendment) Regulations (Northern Ireland) 1994 and shall come into operation on 24th October 1994.
- (2) In these regulations, "the principal regulations" means the Registration of Clubs (Required Information) Regulations (Northern Ireland) 1988(b).

Amendment of regulation 2 of the principal regulations

- **2.**—(1) Regulation 2(1)(e) is hereby revoked.
- (2) In Regulation 2(1)(f) of the principal regulations after "club" there shall be inserted "where available".

Amendment of regulation 3 of the principal regulations

- **3.**—(1) Regulation 3(1)(e) and (f) are hereby revoked.
- (2) In Regulation 3(1)(g) for "that year" there shall be substituted "the year immediately preceding the renewal date;";
 - (3) In Regulation 3(4) reference to paragraph 1(e) shall be deleted.

Revocation

4. The Schedule to the principal regulations is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These regulations amend the Registration of Clubs (Required Information) Regulations (Northern Ireland) 1988 ("the principal regulations") which set out the information required on application for the grant or renewal of registration of a club for the purposes of supplying, and keeping for supply, intoxicating liquor to its members and their guests on club premises.

Regulation 2(1) revokes regulation 2(1)(e) of the principal regulations, so that on an application for grant of registration it is no longer necessary to submit a Form of Declaration.

Regulation 2(2) amends regulation 2(1)(f) of the principal regulations by requiring, as information, a copy of the minutes of the inaugural meeting of the club where available.

Regulation 3(1) revokes regulation 3(1)(e) and (f) of the principal regulations so that on application for renewal of registration it is no longer necessary to submit a Form of Declaration or a copy of the minutes of the meetings of the committee of management or governing body of the club for the preceding year.
