## ROAD TRAFFIC AND VEHICLES

**Motor Vehicles (Taxi Drivers' Licences) (Fees)  
(Amendment) Regulations (Northern Ireland) 1994**

*Made* . . . . . 24th October 1994

*Coming into operation* . . . . . 1st December 1994

The Department of the Environment, in exercise of the powers conferred on it by Articles 79A(2) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a), and of all other powers enabling it in that behalf, and with the approval of the Department of Finance and Personnel as regards regulation 2, hereby makes the following Regulations:

*Citation and commencement*

1. These Regulations may be cited as the Motor Vehicles (Taxi Drivers' Licences) (Fees) (Amendment) Regulations (Northern Ireland) 1994 and shall come into operation on 1st December 1994.

*Amendment of the Motor Vehicles (Taxi Drivers' Licences) Regulations (Northern Ireland) 1991*

2. The Motor Vehicles (Taxi Drivers' Licences) Regulations (Northern Ireland) 1991(b) shall be amended as follows—

- (1) In regulation 4(1) (fee for a licence) for “£65·70” there shall be substituted “£75·50” and for “£43” there shall be substituted “£52”.
- (2) In regulation 5(4) (grant of new licences to replace lost, stolen, defaced or destroyed licences) for “£8·80” there shall be substituted “£9”.

*Revocation*

3. The Motor Vehicles (Taxi Drivers' Licences) (Fees) (Amendment) Regulations (Northern Ireland) 1993(c) are hereby revoked.

#### EXPLANATORY NOTE

*(This note is not part of the Regulations.)*

These Regulations further amend the Motor Vehicles (Taxi Drivers' Licences) Regulations (Northern Ireland) 1991 by increasing the fee payable—

- (1) for a first licence from £65·70 to £75·50 and the fee for the renewal of a licence from £43·00 to £52; and
- (2) for a new licence where a licence has been lost, stolen, accidentally defaced or destroyed from £8·80 to £9.

Regulation 3 revokes the Motor Vehicles (Taxi Drivers' Licences) (Fees) (Amendment) Regulations (Northern Ireland) 1993.
