ROAD TRAFFIC AND VEHICLES

Off-Street Parking (Amendment) Bye-Laws
(Northern Ireland) 1994

Made 25th October 1994

Coming into operation 6th December 1994

The Department of the Environment in exercise of the powers conferred on it by Article 105(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf, makes the following bye-laws:

Citation and commencement

1. These bye-laws may be cited as the Off-Street Parking (Amendment) Bye-Laws (Northern Ireland) 1994 and shall come into operation on 6th December 1994.

Amendment

2. Schedule 1 to the Off-Street Parking Bye-Laws (Northern Ireland) 1994(b) shall be amended by the—

- (a) deletion from Part I of the item numbered 92 relating to Stroud Street, Belfast;
- (b) addition to Part I of the items in Schedule 1;
- (c) substitution for item 221 in Part I of the item in Schedule 2;
- (d) substitution for the scale of charges in relation to Tariff E in Part II of those specified in Schedule 3;
- (e) deletion from Part III of Stroud Street, Belfast; and
- (f) addition to Part III of "Donegall Road, Belfast" and "Perry Street, Dungannon".
