The General Grant (Specified Bodies) Regulations (Northern Ireland) 1994

27th October 1994 Made 8th December 1994 Coming into operation

The Department of the Environment, in exercise of the powers conferred by Article 4(3) of the Local Government & c (Northern Ireland) Order 1972(a) and now vested in it(b), and of all other powers enabling it in that behalf, after consultation with such associations or bodies representative of district councils and such district councils as appear to it to be appropriate, hereby makes the following Regulations:-

Citation and commencement

1. These regulations may be cited as the General Grant (Specified Bodies) Regulations (Northern Ireland) 1994 and shall come into operation on 8th December 1994.

Specified bodies

- 2. The following bodies are hereby specified for the purposes of Article 4(3) of the Local Government & c (Northern Ireland) Order 1972 namely—
 - (a) National Joint Council for Local Authorities' Administrative. Professional Technical and Clerical Services.
 - (b) National Joint Council for Local Authorities' Services (Manual Workers).
 - (c) Northern Ireland Joint Council for Local Authorities' Administrative, Professional, Technical and Clerical Services.
 - (d) Northern Ireland Joint Industrial Council for Local Authorities' Services (Manual Workers).
 - (e) Joint Negotiating Committee for Clerks/Chief Executives of Local Authorities in Northern Ireland.
 - (f) Local Government Training Group.
 - (g) Local Authorities' Co-ordinating Body on Trading Standards (LACOTS).
 - (h) Local Government International Bureau.

EXPLANATORY NOTE

(This note is not part of the Order.)

These Regulations consolidate, with one minor amendment, the General Grant (Specified Bodies) Regulations (Northern Ireland) 1986 and the General Grant (Specified Bodies) (Amendment) Regulations (Northern Ireland) 1989 (Regulation 2) and revoke those Regulations (Regulation 3).
