The Department of the Environment, in exercise of the powers conferred on it by Articles 211(2) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a) and of all other powers enabling it in that behalf, hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Cycle Racing on Roads (Amendment) Regulations (Northern Ireland) 1994 and shall come into operation on 19th December 1994.

Amendment of the 1986 Regulations

2. Regulation 5 of the Cycle Racing on Roads Regulations (Northern Ireland) 1986(b) is amended as follows-

(1) In paragraph (a) in sub-paragraph (i) for Head (A) substitute—

"(A) in 2 races in any one year one of which may be selected by the Northern Ireland Cycling Federation and the other of which may be selected by the Ulster Cycling Federation, 100;".

(2) Paragraph (b) is re-numbered "(b)(ii)" and immediately before it insert the following new paragraph—

> "(b) (i) the promoter of a race referred to in paragraph (a)(i)(A), in addition to the requirements of sub-paragraph (ii), gives to the appropriate officer of police in writing notice of the date on which the race is to be held, on or before the 1st January of the year in which the race is to be held; and".

Road Traffic and Vehicles EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Cycle Racing on Roads Regulations (Northern Ireland) 1986 as follows—

(1) Regulation 5(a)(i)(A) is substituted to make it clear that each. Federation named therein can nominate only one race in any one year, and to change the reference to the National Cycling Association of Ireland (Ulster Council) to the Ulster Cycling Federation.

(2) Regulation 5(b) is amended by inserting a requirement that the date of a cycle race selected by either the Northern Ireland Cycling Federation or the Ulster Cycling Federation, shall be notified to the appropriate officer of police in writing on or before the 1st January of the year in which the race is to be held.

Medicines (Standard Provisions for Manufacturer's Licences for Veterinary Medicinal Products) Regulations 1994

These Regulations have been made by the Secretary of State concerned with health in England, the Secretaries of State respectively concerned with health and with agriculture in Scotland and in Wales, the Minister of Agriculture, Fisheries and Food, the Department of Health and Social Services for Northern Ireland, and the Department of Agriculture for Northern Ireland, acting jointly, in exercise of the powers conferred by sections 47(1) and 129(5) of the Medicines Act 1968.

In pursuance of paragraph 11 of Schedule 4 to that Act these Regulations have been registered as a Northern Ireland statutory rule under the Statutory Rules (Northern Ireland) Order 1979. They are printed in full in the volume of United Kingdom Statutory Instruments for 1994 and have been numbered 2852 in that series.
