Control of Traffic (Belfast) (No. 2) Order (Amendment) Order (Northern Ireland) 1994

11th January 1994 Made Coming into operation . 22nd February 1994

WHEREAS the Department of the Environment has published a notice in compliance with Article 23(1) and (2) of the Road Traffic (Northern Ireland) Order 1981(a);

AND WHEREAS no objection or representation has been received;

NOW THEREFORE the Department, in exercise of the powers conferred on it by Article 21(1) of the Road Traffic (Northern Ireland) Order 1981 and of every other power enabling it in that behalf, makes the following Order:

Citation and commencement

1. This Order may be cited as the Control of Traffic (Belfast) (No. 2) Order (Amendment) Order (Northern Ireland) 1994 and shall come into operation on 22nd February 1994.

Amendment

- 2. The Control of Traffic (Belfast) (No. 2) Order (Northern Ireland) 1987(b) shall be amended as follows—
 - (1) After Article 4 add the following new Articles—
 - "Compulsory left-hand turn
 - 5. Every person causing or permitting a vehicle to proceed in a north-westerly direction along Little Patrick Street, Belfast, on reaching its junction with Nelson Street shall, except upon the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit that vehicle to make a left-hand turn into Nelson Street.

Compulsory right-hand turn

- 6. Every person causing or permitting a vehicle to proceed in a south-easterly direction along Little Patrick Street, Belfast, on reaching its junction with Nelson Street shall, except upon the direction or with the permission of a constable in uniform or of a traffic warden, cause or permit that vehicle to make a right-hand turn into Nelson Street.".
- (2) In Schedules 2 and 3 delete the items relating to Little Patrick Street.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order amends the Control of Traffic (Belfast) (No. 2) Order (Northern Ireland) 1987 (S.R. 1987 No. 159).

The effect of the amendment is to provide for a compulsory left-hand turn into Nelson Street, Belfast, for vehicles travelling in a north-westerly direction along Little Patrick Street, and for a compulsory right-hand turn into Nelson Street for vehicles travelling in a south-easterly direction along Little Patrick Street.

Any person who acts in contravention of the Order shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£400).

Traffic signs indicating the effect of the Order will in due course be erected on the roads.
