WHEREAS the Department of the Environment has published a notice in compliance with Article 23(1) and (2) of the Road Traffic (Northern Ireland) Order 1981(a);

AND WHEREAS no objection or representation has been received;

NOW THEREFORE the Department, in exercise of the powers conferred on it by Article 22(1) of the Road Traffic (Northern Ireland) Order 1981 and of every other power enabling it in that behalf and being satisfied that the road specified in Article 2 is unsuitable for use by certain classes of vehicles, makes the following Order:

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Traffic Weight Restriction (Manooney Road, Killylea) Order (Northern Ireland) 1994 and shall come into operation on 25th April 1994.

(2) In this Order "maximum gross weight" has the meaning assigned to that term by regulation 2(1) of the Motor Vehicles (Construction and Use) Regulations (Northern Ireland) 1989(b).

Prohibition

2. Subject to Article 3 the use by vehicles exceeding 7.5 tonnes maximum gross weight is prohibited in Manooney Road, Unclassified No. 8733, Killylea, County Armagh.

Exceptions

- 3. The prohibition in Article 2 shall not apply to vehicles being used—
- (a) by the owners or occupiers of lands abutting on or convenient to the road to gain access to such land; or
- (b) in connection with the delivery to or collection from such land of goods of any kind including livestock; or

- (c) for police or military purposes, or in an emergency for ambulance or fire brigade purposes; or
- (d) in connection with public utility services in or adjacent to the road.

EXPLANATORY NOTE

(This note is not part of the Order.)

This Order prohibits vehicles exceeding 7.5 tonnes maximum gross weight from using Manooney Road, Unclassified No. 8733, Killylea, County Armagh.

Vehicles requiring access are excepted from the provisions of the Order.

Any person who acts in contravention of the Order shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale ($\pounds 400$).

Traffic signs indicating the effect of the Order will in due course be erected on the road.
