Magistrates' Courts Fees (Amendment) Order
(Northern Ireland) 1995

Made 22nd May 1995

Coming into operation 1st June 1995

The Lord Chancellor, in exercise of the powers conferred on him by section 116(1) of the Judicature (Northern Ireland) Act 1978(a), after consultation with the Lord Chief Justice, and with the concurrence of the Treasury, hereby makes the following Order:—

1. This Order may be cited as the Magistrates' Courts Fees (Amendment) Order (Northern Ireland) 1995 and shall come into operation on 1st June 1995.

2. For Schedule 1 to the Magistrates' Courts Fees Order (Northern Ireland) 1994(b) there shall be substituted the new Schedule 1 set out in the Schedule to this Order.

EXPLANATORY NOTE

This Order amends the Magistrates' Courts Fees Order (Northern Ireland) 1994 by substituting a new Schedule 1 to increase a number of the fees to be taken in magistrates' courts proceedings.
