**Landing of Carcasses and Animal Products (Amendment)
Order (Northern Ireland) 1995**

Made 9th August 1995

Coming into operation 6th September 1995

The Department of Agriculture, in exercise of the powers conferred on it by Articles 24(1) and 60(1) of the Diseases of Animals (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Landing of Carcasses and Animal Products (Amendment) Order (Northern Ireland) 1995 and shall come into operation on 6th September 1995.

Amendment of the Landing of Carcasses and Animal Products Order 1985

2. The Landing of Carcasses and Animal Products Order (Northern Ireland) 1985(b) shall be amended as provided in Articles 3 to 7.

3. For Article 3 there shall be substituted the following Article—

“3.—(1) Subject to paragraph (2), this Order applies to any carcase or animal product and to any other product, whether uncooked, cooked or otherwise processed, containing meat or offal of an animal.

(2) This Order shall not apply to animal products which are subject to any of the statutory provisions listed in the Schedule.”

4. In Article 4(1) the words “Subject to Article 5” shall be omitted.

5. Article 5 shall be revoked.

6. The Importation of Semen, Embryos and Ova Order (Northern Ireland) 1993(c) is hereby revoked.

7. The following Schedule shall be substituted for the Schedule:—
