ROAD TRAFFIC AND VEHICLES

Roads (Speed Limit) (No. 3) Order (Northern Ireland) 1995

The Department of the Environment, in exercise of the powers conferred on it by Article 50(4)(c) of the Road Traffic (Northern Ireland) Order 1981(a) and of every other power enabling it in that behalf, hereby makes the following Order:

Citation and commencement

1. This Order may be cited as the Roads (Speed Limit) (No. 3) Order (Northern Ireland) 1995 and shall come into operation on 4th January 1996.

Speed restrictions on certain roads

2. The Department hereby directs that each of the roads and lengths of road specified in Schedule 1 shall be a restricted road for the purposes of Article 50 of the Road Traffic (Northern Ireland) Order 1981.

Revocations

3. The provisions described in Schedule 2 are hereby revoked.

Restricted Roads

Road Traffic and Vehicles EXPLANATORY NOTE

(This note is not part of the Order.)

This Order makes the roads and lengths of road in Schedule 1 restricted roads, thereby imposing a 30 miles per hour speed limit on those roads.

The lengths of road to which the items revoked under paragraphs 1, 3, 4, 5 (item No. 334), 6, 8 (item Nos. 451, 493 and 514) and 9 of Schedule 2 relate are now comprised in greater lengths of road described in item Nos. 11, 1, 30, 48, 5, 38, 49, 8 and 6 respectively of Schedule 1.

The length of road to which the item revoked under paragraph 2 of Schedule 2 relates is now comprised in item Nos. 15, 16 and 17 of Schedule 1.

The length of road to which the item revoked under paragraph 5 (item No. 4) of Schedule 2 relates is now comprised in item Nos. 12 and 36 of Schedule 1.

The length of road to which the item revoked under paragraph 5 (item No. 287) of Schedule 2 relates is now comprised in part of the length of road described in item No. 13 and in the length of road described in item No. 14 of Schedule 1.

The length of road to which the item revoked under paragraph 7 of Schedule 2 relates does not exist.

The length of road to which the item revoked under paragraph 8 (item No. 473) of Schedule 2 relates was previously incorrectly defined. The correct length of road is now comprised in a greater length of road described in item No. 40 of Schedule 1.

The length of road to which the items revoked under paragraph 10 of Schedule 2 relate is redescribed in item No. 41 of Schedule 1 and is now a restricted road.

The road and length of road to which the items revoked under paragraph 11 of Schedule 2 relate have been renamed and are now comprised in item Nos. 47 and 44 respectively of Schedule 1.

The length of road to which the item revoked under paragraph 12 of Schedule 2 relates is now comprised in item Nos. 45 and 46 of Schedule 1 because that part of its length in item No. 46 has been re-classified.
