DISABLED PERSONS

The Disability Discrimination Act 1995 (Commencement No. 2) Order (Northern Ireland) 1996

Made - - - - 30th May 1996

The Department of Health and Social Services, in exercise of the powers conferred on it by section 70(3) of the Disability Discrimination Act 1995(1) and of all other powers enabling it in that behalf, hereby makes the following Order:

Citation

1. This Order may be cited as the Disability Discrimination Act 1995 (Commencement No. 2) Order (Northern Ireland) 1996.

Appointed day

2. The day appointed for the coming into operation of the provisions of the Disability Discrimination Act 1995 specified in Article 3 is 30th May 1996.

Provisions commenced

- **3.** The provisions referred to in Article 2 are—
 - (a) section 1 (Meaning of "disability" and "disabled person");
 - (b) section 2 (Past disabilities);
 - (c) section 3(2) (Guidance);
 - (d) section 16(3) in so far as it relates to the definitions of "sub-lease" and "sub-tenancy", and (5) in so far as it relates to paragraph 4(3) of Schedule 4 (Sub-leases etc.);
 - (e) section 28(4) (Provision of advice and assistance);
 - (f) section 59(5) (Statutory authority and national security);
