ROAD TRAFFIC AND VEHICLES

Public Service Vehicles (Licence Fees) (Amendment) Regulations (Northern Ireland) 2001

Made 21st June 2001 Coming into operation 1st August 2001

The Department of the Environment, in exercise of the powers conferred on it by Articles 61(1), 66(1) and 218(1) of the Road Traffic (Northern Ireland) Order 1981(a), and of every other power enabling it in that behalf, and with the approval of the Department of Finance and Personnel(b), hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Public Service Vehicles (Licence Fees) (Amendment) Regulations (Northern Ireland) 2001 and shall come into operation on 1st August 2001.

Amendment of the Public Service Vehicles Regulations (Northern Ireland)

2. In the Public Service Vehicles Regulations (Northern Ireland) 1985(c) for Schedule 7 there shall be substituted—

EXPLANATORY NOTE

(This note is not part of the Regulations.)

These Regulations amend the Public Service Vehicles Regulations (Northern Ireland) 1985 by increasing the fee payable—

- (1) For an initial or re-application for a vehicle licence for—
- (a) Buses—

Class I, II and III from £45.00 to £46.50;

Class IA, from £52.50 to £54.00;

Class IIA, from £62.00 to £63.50; and

Class IIIA, from £71.50 to £73.00;

- (b) Taxi, from £32.00 to £33.50.
- (2) For a re-application for a vehicle licence made within 21 days from the date of the service of the notice of refusal for—
 - (a) Buses, all Classes, from £12.50 to £13.50; and
 - (b) Taxi, from £11.00 to £12.00.
- (3) For a re-application under regulation 9(4) within 21 days from the date of the service of the notice of refusal for—

Buses—

Class IA, from £12.50 to £13.50;

Class IIA, from £22.00 to £23.00; and

Class IIIA from £31.50 to £32.50.

- (4) For a duplicate vehicle licence for—
- (a) Buses, all Classes, from £9.00 to £10.00; and
- (b) Taxi, from £9.00 to £10.00.
